ABOUT THE PROFESSOR:

Teaching Philosophy:

As a professor, I curate deliberate examples from the art world that engage, challenge and inspire my students.
Bringing fine art into my classroom creates an environment where students enter a rigorous creative think tank.
Through a range of examples spreading over history, I guide students to ask paramount questions concerning the creative process and develop a unique perspective on how they formulate an educated opinion about art and their visual world.

ABOUT THE COURSE:

Course Description:

This introduction to the visual arts is designed for the general student, as an exploration of purposes and processes in the visual arts including evaluation of selected works. This course presents a survey of the visual arts, including artistic media and techniques, and art history. Students will also explore visual principles and elements through handson activities.

Professor Ham's Perspective:

In Art Appreciation, we will be looking at the basic principles of design, medium, history, and context which animate contemporary and historic art. This will serve as an introduction to the art world and empower students to be critical viewers.

Course Structure:

We will complete three lesson units this semester. Each lesson unit will last three weeks. In each unit you will complete the follwing tasks:

- Complete assigned reading quizzes from the course textbook.
- Participate in and complete an art project related to the unit's assigned reading.

At the end of the semester students will also complete two major assignments. One assignment will be a short analysis and interpretation based assignment. The other will be a final creative project that tasks the student with generating their own work of art.

I will use Blackboard to provide you with copies of the syllabus, calendar, and other course materials. This will also be where the most up-to-date grading information will be shared with you. Make sure you regularly check Blackboard for updates.

- Communicated our ideas clearly in your writing, verbal language, and artwork.
- Mobilized your individual strengths to work collaboratively as part of a team to accomplish a final project.
- Engaged with the local, national, and global art and better understand diverse perspectives and practices of art.

BASIC EXPECTATIONS:

Standards of Campus Conduct:

• You will be able to accrue 4 absences without penalty in this class. These absences will not alter due dates, and reading quizzes cannot be made up.

- •The 5th absence will lower your course grade one full letter grade. Each additional absence will also lower your course grade by one full letter grade.
- •Students who accumulate 7 or more absences are strongly advised to drop this course to avoid damage to your GPA.
- Be aware that you are only permitted a total of 6 drops without penalty in your undergraduate career. The 7th drop will be calculated as an F in your GPA. Be cautious about casually dropping classes.
- Arriving late or leaving class early may be considered an absence.
- Arriving to class unprepared may be considered as absent.
- Working on other class materials or not actively participating may be considered an absence.
- Attendance is calculated for each day of class meetings. Students enrolling after the first class day are counted absent for the days missed prior to enrollment.

Financial Aid and Verification of Attendance:

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will

COURSE ASSIGNMENTS:

Reading Quizzes:

You will be assigned reading in our textbook, Gateways to Art 4th Edition. You will then be quizzed on Blackboard over the material covered in the reading. The quiz must be completed by 9AM each Tuesday.

Reading Quizzes will count for 25% of your final grade.

Art Projects

Each unit you will be assigned an art project that will give tactile experience of the principles we've discussed in the lecture portion of the class. Each assignment will be outlined on an assignment sheet made available on Blackboard.

Art projects will count for 30% of your final grade.

Visual Analysis Assignment

At the end of the semester students will complete a visual analysis assignment that asks them to utilize the information learned in the course to create an interpretation of a selected artwork. The Visual Analysis Assignment will count for 15% of your final grade.

Final Creative Project

Students will propose and execute a self-determined creative assignment that draws on the methods learned throughout the semester via the hands-on assignments. This project will corresp ond directly to the VAA assignment asn will be explained in class.

The Final Creative Project will count for 30% of your final grade.
