Catalog Course Description: This course approaches accounting from the point of view of a business manager. Emphasis is on the source, strengths, and limitations of financial accounting information as a support for the five functions of management, i.e. planning, organizing, staffing, directing, and controlling. The course culminates in the analysis of publicly available financial statements, using both vertical and horizontal analysis techniques. This course is specifically designed for non-accounting majors.

Prerequisite: ACCT 2301 and ACCT 2302 or equivalent.

### **Course Objectives:**

The objective of the course is for students to be able to:

- Learn the components of the basic statements including income statement, balance sheet, and cash flow statement.
- Familiarize students with the character of statements for difference enterprises.
- Be able to identify cost allocation such as depreciation.
- Be able to compute break even and target profit analysis.
- Identify direct material, direct labor and overhead costs.
- Distinguish between job order and process costings.
- Calculate allocated overhead.
- Identify and calculate variances.
- Identify segment analysis and profitability measures.
- Recognize and identify basic concepts of fixed, variable and mixed costs.

**Prerequisites:** ACCT 2301 and ACCT 2302 or equivalent. Students who do not meet the pre-requisites must contact the instructor immediately.

### **Student Learning Outcomes:**

After successful completion of this course, students will be able to:

- Basic accounting principles
- Financial ratios, gross margin/gross profit percentages
- Closing entries
- Depreciation computation including straight-line, sum of years digits, declining balance, units of production
- Accounting for notes and debt (I=PxRxT)
- Managerial cost concepts such as fixed, variable and overhead costs
- Basic understanding of problem solving in Algebra 1
- Basic use of Excel and Word
- Ability to access Blackboard and Textbook websites

### **AACSB Assessment:**

  internet connection, a microphone and speakers/headphones. To complete the class work, you will
  need appropriate software installed on the computer.

### Course Requirements every student must fulfill in order to succeed in course:

- 1. Students should check the Course Calendar, Announcements, and Messages (e-mail) systems in Blackboard on a regular basis.
- 2. Students should keep current with all course assignments, quizzes, and examinations.
- 3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.

All materials will be made available through Blackboard or through online links.

**Grading Policy:** The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows:

Above  $90\% \Rightarrow A$ ;  $80 - 89\% \Rightarrow B$ ;  $70 - 79\% \Rightarrow C$ ;  $60 - 69\% \Rightarrow D$ ; Below  $60\% \Rightarrow F$ .

This course has a requirement of a grade of C as a minimal grade for satisfactory completion of this course.

**Examinations and Quizzes:** There will be a mandatory final exam (as per university schedule). Being absent / non-submission of an exam will result in a grade of zero for that exam and may result in a fail grade in the course. The exams/quizzes will consist of conceptual multiple-choice questions, and problem-solving questions. The exams/quiz materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class.

**Proctored Exams:** Examinations in this class may/will be administered using secure online testing services. Details regarding proctored test sign up and administration will be provided at least 2 weeks prior to the exam.

Assignments/ Research papers: There will be several assignments during the course. Individual assignment statements and due dates will be posted through Blackboard. For all assignment and quiz problems, ALL intermediate work of the problem solution steps MUST be shown. This includes the use of the formula, the values substituted in the formulas for problem solution, as well the intermediate steps of the arithmetic computation. The units of measurement are extremely important and MUST be shown at each stage of the computation. Considerable points will be taken off for not following these requirements.

### Make up and Late Assignment/exam/quiz policy:

As a general rule, make-ups or late submissions will **NOT** be offered or accepted for any missed <u>assignments/exams/quizzes</u>. Late submissions or make-ups may be accepted/administered only in extraordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

Class attendance and Participation: A vital part of every student's education is regular attendance of class meetings (for face-to-face/hybrid classes/online synchronous classes) or regular review of class materials posted by the instructor for asynchronous classes. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class. The course covers a lot of material and most students find at least some parts of it difficult. Class participation is highly encouraged as it makes the class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions, participate in class discussions and problem solving, and visit/contact the instructor during office hours in case of questions or concerns. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important and may vary considerably based on student background. However, a **minimum** of two hours of work outside the class is expected for everyone hour of class period per week. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.
