Course Description:

This course provides an in-depth examination of juvenile delinquency. We explore its nature, causes, consequences, and society responses. Students will critically assess theoretical frameworks, empirical research, and public policy.

Course Learning Outcomes:

The primary objective of this course is to introduce the student to nature, causes, consequences, and societal responses to juvenile delinquency in our criminal justice system.

Upon completion of this course, you will have an understanding of 1) historical and contemporary nature of juvenile delinquency, 2) Evaluate criminological, and sociological theories of delinquent behavior, 3) Critically assess juvenile justice systems, practices, and policies, 4) Propose evidence-based prevention and intervention strategies, and 5) Interpret and critique empirical research.

Class Format:

This course will consist of research articles, discussion forums, policy papers, and a final report. You are expected to complete all the assigned readings, discussion forums, policy papers, and the final report.

Late Assignment Policy:

Students are expected to turn in work on time. Work submitted late but within 24 hours of the due date and time will receive a 50% penalty. If you are struggling to meet due dates because of personal hardships, please contact me to discuss options.

Syllabus Change Policy:

The syllabus is subject to change with reasonable advanced notice as course needs arise. It will and can change based on the instructor's judgment or the evaluation of the class progress throughout the semester. **Depending on the progress of the semester, the schedule, assignment, and exam dates will change.** When Change is made in the schedule, you will be notified via Black Board Announcement tab. Assessments

Discussion Posts (150 points):

You will complete ten discussion posts worth 15 points each (please see rubric in the instructions provided on BB) throughout the semester. On Blackboard, prompt-based questions will be posted. You will respond with an ORIGINAL post (500 words Minimum) of your own. Furthermore, you will provide a minimum of TWO responses (200 words each minimum) to classmates' posts. Here, you will be assessed 1) The depth of your analysis regarding the topic provided, 2) Appropriate use and integration of scholarly sources with correct citations, 3) Thoughtfulness and respect in peer responses, 4) Clarity, organizational flow, and grammar.

Additionally, APA format (including structure and citation methods) is required. Minimum word count provided above is required. If you do not meet the minimum requirement, it will be an automatic zero.

Reading Response Paper (150 Points):

You will complete three reading response papers worth 50 points each. Each paper will be a minimum of 1000 words with proper citation, and APA formatting as its minimum requirement. For the reading responses, your goal is to show your understanding and interpretation of the topic. The key point here is your assessment. You are required to critique the reading and provide your evaluation of it. Furthermore, you are required to provide empirical evidence to support your evaluation of the material that you have critiqued. You will be assessed on the 1) Accuracy of your comprehension of the material, 2) Original insight or critique, 3) Appropriate use of scholarly evidence and citation methods, and 4) Overall writing quality. The violation of the minimum requirement will be an automatic zero.

Policy Presentation (100 points):

For your final report, pretend that you are presenting a policy to your government officials. You will present a policy presentation. Here, your job is to present and evaluate an issue that you want to address regarding juvenile delinquency in our justice system. Afterwards, you will provide an in-depth analysis of how you can fix this, in what way, and provide empirical evidence to support your argument. The presentation will be **at least 25 minutes** (maximum of 30). You are also required to have a PowerPoint presentation as a visual aid while you present. Finally, you will be recording this entire presentation via Zoom recording (Any other recording will not be permitted). Zoom will be enforced to ensure that all student are able to submit their video file (mp4) on Blackboard.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV



funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class. Any student receiving federal financial aid who does not attend the first week of class will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.
