COURSE DESCRIPTION:

Native American and Spanish background; Mexican, Anglo, and African American settlement; the Revolution and Republic; statehood; economic, political, and cultural development.

LEARNING OUTCOMES:

At the end of this course, the student will be able to:

- 1) Interpret the major events and movements in Texas History.
- 2) Compare and contrast experiences of people based upon various categories of analysis.
- 3) Analyze this history in its broader social, political, economic, and cultural contexts.
- 4) Evaluate research problems & interpretive issues in the field of Texas history using primary and secondary sources.

ASSIGNMENTS:

<u>ATTENDANCE</u> (10%): Students are expected to attend class in person each week (see Course Calendar below, pp. 7-8, for class meeting dates). If you know in advance that you will miss a scheduled class meeting, please notify me immediately so that you will not be marked absent. You will be **allowed one unexcused absence**, but still responsible for any missed assignment. Note that **two unexcused absences** from class meetings will result in a **drop of one letter grade** from your overall final grade for the course and an "F" for **three or more unexcused absences**. In any event, communication is key.

READINGS, FILMS, DISCUSSION, QUIZZES (30%): Students will be graded on the quality of their contributions and ability to analyze and discuss course concepts. You will be asked to submit brief written responses to assigned readings, film documentaries, primary sources, and take quizzes. Please be respectful and courteous of your peers in any online discussion. *Note:* Points may be subtracted from your grade/score for being turned in past the due date or a zero for no submission of an assignment.

ANALYTICAL PAPER (20%):

I will provide you with a Guide (& Rubric) to Writing the Analytical Paper. The format for this paper will be three pages in length (or 750 words), typed, double-spaced, and 12-point font (Times New Roman). You will analyze the scholarly essay by Amy Porter, "Tejanas and Ranching: María Calvillo and Her Ranching Enterprise." Your paper is to be submitted through *Turnitin* in Blackboard Ultra (BU), which checks for plagiarism and AI (see Academic Misconduct Policy below). The *Due Date* for the Book Review is *Tuesday, September 23*. *Note:* Points may be subtracted from your score for being turned in past the due date.

EXAMS (40%): I will provide you with a Guide to the **Mid-Term Exam** and a Guide to the **Final Exam** via Blackboard about one week prior to each exam date. The format for both exams will be a short-answer section and a long-essay section to be taken during class on the scheduled date (see Course Calendar below, pages 7-8, for the exam dates).

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including

students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. Students' Rights

- 2. - 4. Each student subject to disciplinary action arising from violations of university student rules shall be assured a fundamentally fair process.

Students' Responsibilities

- 1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
- 2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, <u>Student Code of Conduct</u>, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
- 3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
- 4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
