#### **Catalog Description and Prerequisites:**

In this course we will explore the fundamental concepts of innate and adaptive immunity. We will also discover how the immune system responds to infection and the role of inflammation in various disease processes. Prerequisites: BIOL 1406 and 1407

## **Learning objectives**

- 1. Student will be able to discuss the basic principles of immunity including cell types, receptors, and mediators of innate and adaptive immunity.
- 2. Students will be able to discuss the role of inflammation in infectious and noninfectious diseases.

## **Course Content**

#### **LECTURE**

## **GENERAL POLICIES:**

#### **Lecture Attendance:**

Although points will not be assessed regularly for attendance during regular lectures, <u>I reserve the right</u> to randomly take attendance and assess points for that day (for example, I may assign an in-class discussion or assignment that can be used to assess points for attendance). Regardless of whether points are assessed, I will take attendance daily as it will be used at the end of the semester as an additional evaluation of your performance (i.e. if your grade is borderline and you have attended class regularly I will be more inclined to bump you up to the next grade). If you must miss a class, <u>you</u> are responsible for obtaining what you missed (announcements, class notes, handouts, etc...) <u>from a fellow classmate, not</u> <u>me</u>. Again, I repeat, if you miss class do not assume that I will post whether an assignment was assigned, or when something is due – it is <u>YOUR RESPONSIBILITY</u> to find out what you missed by asking a FELLOW CLASSMATE. Likely this fellow classmate will be one of your group members.

#### Grading

This course combines a lecture and laboratory section. These two sections will have different weight in your final grade for the course. The lecture section will be worth 75% of your course grade. The laboratory section will be worth 25% of your grade.

#### **Grade Scheme:**

I would *not* scale up from a B to an A (regardless of your attendance) if you have earned an <u>89.4%</u>.



<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
