Course objective: The immunology lab is designed to provide students with hands-on experience in immunology and perform assignments and experiments that reinforce and enhance the material learned in lecture. The students will learn techniques utilized currently in research laboratories. Additionally, the students will maintain a lab notebook in order to learn and practice the process of scientific record keeping.

Required:

- 1) Signed safety agreement prior to start of second lab period.
- 2) Lab coats must be purchased and worn in the lab every week. If you forget your coat, you will be required to rent one for \$2 or leave the lab for the day and take a zero.

**Weekly quizzes –**

- There will be a weekly 10-minute quiz at the beginning of every lab. Quizzes will include previous week's material and a few questions regarding what we will be doing that day.
- There will be no provisions for making up laboratory quizzes due to the nature of the quizzes
- You may drop your lowest quiz IF you have not missed any of the quizzes. Alternatively you can view this as missing one quiz without penalty (i.e. if some unforeseen circumstance arises and you cannot attend lab).

Grading: The grade for the lab will be combined with lecture. **The lab constitutes 25% of your BIOL 4408 grade.**

**Grading Scheme:**

**Attendance** – Mandatory. Attendance counts for **40% of your lab grade**. In addition, if a student misses more than 3 laboratory classes in a regular semester then the student will automatically fail the course.

**Lab handouts and/or quizzes:** Worksheets/quizzes count for **40% of your lab grade**

**Final Lab report/Lab Notebook/or Presentation:** The final lab notebook report, final exam, or presentation will count for **20% of your final lab grade**.

Late Arrival Policy: Students who arrive more than **20 minutes late** will not be permitted to enter the lab or complete the activity for that day. It is the student's responsibility to notify the instructor in advance if they anticipate being late beyond this limit.

Deadlines: Late papers or worksheets will only be accepted within 24 hours of the due date and 10% will be automatically deducted.

Lab report: You may be conducting a multi-week experiments. These experiments will require a few instances where the student must come in outside of scheduled lab time (i.e. during designated "open lab" periods) to check on the experiment. Keeping up with this experiment is also part of your participation grade. The lab report will be due in 3 increments and is a major part of your lab grade. Please access the university writing center during the writing of this report if you need help with grammar, punctuation, writing style etc. A rubric will be provided regarding the scientific content.

Communication: All students are expected to access Blackboard for updates on the course and to find the course materials. I am available during office hours if you need clarification on material and assignments in this course, and I am happy to make appointments at other times. Email is also an excellent way to get in touch with me.

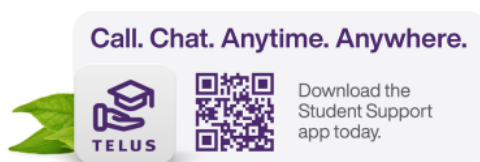

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.
