Course description: Student-led reviews of current scientific literature on various topics in biology with critical class analyses. Students will refine their ability to search, read, understand, discuss and critique the primary scientific literature, both orally and in written form. Prerequisite(s): BIOL 3402 and ENGL 2311 or ENGL 1302 must be completed first.

Course objectives: This course is designed as a writing intentional course in order to give students maximum opportunity to hone their scientific skills by accessing the scientific research literature directly and communicating their understanding of these scientific articles in written form. As such, class periods will include workshops aimed at improving scientific writing as well as student-driven discussion with my role as facilitator. For effective discussion, all students must come prepared for each class by reading the assigned article(s) in sufficient depth to participate knowledgeably. Attendance for the workshops and discussions is highly important and will be a portion of your grade. Active and thoughtful participation in both workshops and discussions is a key component for your grade in this course.

Attendance policy: Synchronous attendance is mandatory, and points will be assessed every class period. If you have a documented university-excused absence, you will not be penalized for attendance, but you will still be responsible for make-up work.

Workshops: There will be 3 in-class workshops designed to teach aspects of the course required for performance assessment. Some workshops have out-of-class assignments associated with them (see below). However, the workshop must be attended to be eligible to submit a work assignment to reflect your learning of the workshop topic. These workshops cannot be made up.

Discussions: You will be responsible for leading one discussion based on one journal article you have selected. You will submit your first choice article and two backup articles as pdfs, so that a ready alternate is available in cases of inappropriate first choices. The article will be posted on the course website a week prior to the discussion for your classmates in order to give them a week to

read it. You will lead the discussion for ½ of the class period. Bring a flash drive to class with the materials you need for your discussion.

Preparation for the discussion: You will submit annotations of each of the articles containing writing questions and comments prior to discussion. This annotation will both prepare you for the discussion, and provide evidence of your preparation. If there are terms or other things you do not understand in the paper, be sure to look them up and include them in the annotation, but questions make the best preparation for discussion, and increase your performance score. You may annotate the paper by writing directly in the margins of the PDF, alternately you can write your annotations in a text file. In your annotation include two questions or thoughtful comments you had about each article. A file containing your annotations must be submitted prior to the discussion.

Relative contribution to the discussion: In recognition of potential learning by listening to the discussion, and providing an audience, you will earn 10 point for each pair of discussion that you attend and participate in (there are 2 discussions per class period) resulting in a total of 100 points. The other 90 points will be earned by thoughtfully participating 3 times during the discussions. This participation can include asking a good question or making a supportive or critical comment about the paper being discussed or mentioning outside material that adds to the discussion. I will be keeping a checklist each class period to keep track of your participation effort.

Journal Article Critiques: You will write three papers that analyze scientific journal articles. The workshops will help in how to write these.
