Course Description and Material

<u>Catalog Description</u>: Students will study the collection, analysis, presentation, and interpretation of data, and probability. Analysis includes descriptive statistics, correlation and regression, confidence intervals, and hypothesis testing. Appropriate technology will be used. This course meets the standards for the Mathematics category of courses under the core curriculum.

<u>Prerequisites:</u> Evidence of math equivalent to High School Algebra II ("C" or higher) or placement; Requires passing TSIA Math score.

Calculator Policy: A scientific calculator is required. Course lectures will utilize the TI30XIIS scientific calculator.

Student Learning Outcomes: By the end of this course, students will be able to:

- 1. Apply and explain the use of data collection and statistics as tools to reach reasonable conclusions. Recognize and solve mathematics of finance problems, including the computation of interest, annuities, and amortization of loans.
- 2. Recognize, examine and interpret the basic principles of describing and presenting data.

- 3. Compute and interpret empirical and theoretical probabilities using the rules of probabilities and combinatorics.
- 4. Explain the role of probability in statistics.
- 5. Examine, analyze and compare various sampling distributions for basic discrete and continuous random variables.
- 6. Describe, compute and explain confidence intervals.
- 7. Solve and interpret simple linear regression and correlation problems.
- 8. Perform hypothesis testing using statistical methods and interpret results.

Course Expectations and Requirements

<u>Examinations</u>: There will be three exams during the semester: two one-hour exams and one final exam. (The schedule for these exams is in the table below.) Students are expected to take all exams at the scheduled time. Exceptions for a legitimate reason may be granted by and must be approved by the instructor beforehand. In the event that a student misses an exam for unforeseen and dire circumstances (hospitalization, death, nuclear war, ...), the final exam score *may* be used to replace the missing exam score at the instructor's discretion. This is not an advantage for the student since students seldom score as well on the final exam as they do on each hour exam.

<u>Quizzes</u>: There will be a short 20 point quiz at the end of each week (except for exam weeks). The two lowest quiz scores will be dropped, so make-ups will not be necessary. The first few quizzes will be on paper, the remainder will be in Blackboard.

Note: All quizzes and exams are *cumulative*. You can expect questions to cover material from the first day of the course to the day before the quiz or exam.

<u>Homework</u>: There will be approximately 26 homework assignments to be completed in the MyMathLab site provided by Pearson publishing company. These assignments will generally be due Sundays at 11:59 PM. Which homework assignments are due each week will be determined by the weekly progress in lectures. The assignments will be given in lectures.

Students can have group/team discussions about homework problems. However, each student must do his/her own work. Be mindful of academic integrity.

Examples of collaboration on homework:

- 1. A group of students studying together read a problem and then discuss verbally the techniques or strategies they will use to solve the problem. This level of cooperation is allowed.
- 2. One student writes a solution to a problem which other students then use as an example. This level of cooperation is NOT allowed.

Collaboration is allowed on practice quizzes, however no collaboration is allowed on graded quizzes.

Gradebook

This course uses grades from multiple sources (quizzes on paper, quizzes in Blackboard, homework in MyMathLab, etc.) Students should not rely on the Blackboard "Gradebook" or the MyMathLab averages for their in-progress semester grades. Each student will be assigned a randomly determined "Roster Number". The actual in-progress gradebook will be posted in the form of a spreadsheet that gives grades and scores by roster number. This spreadsheet will be posted in a folder titled "Grades Spreadsheet" and updated periodically during the semester. Pay attention to this official gradebook spreadsheet and report any discrepancies to the instructor promptly.

Classroom Etiquette: Students are expected to refrain from distracting classmates as a result of off-task conversation, electronic devices, or other class interruptions.

Electronic Communication Devices: Electronic communication devices (e.g., laptop computer, tablet computer, cellular phone, smart phone) can be useful learning tools, but can also be distractions. Mathematical concepts often require *intense concentration* to grasp, so missing even a few words of classroom discussion can leave a student confused and frustrated. During lecture, use good judgement when and how to use electronic devices. If a student has an urgent situation (e.g., family member in the hospital), inform the instructor at the beginning of class that you wish to leave your cell phone on in case you receive an emergency call.

Recording: If a student wishes to record any part of classroom activity, the student must obtain written permission from the instructor *in advance* of recording. Unauthorized recording can infringe on other class members' rights.

<u>Financial Aid and Verification of Attendance:</u> According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
