## Course Overview, Materials, and Expectations

**Catalog Description:** Math 2113 provides a lab framework for exploring and reinforcing calculus concepts studied in Math 2313 and must be taken concurrently with Math 2313.

**Prerequisite:** Math 2312 Pre-Calculus with a grade of "C" or higher, or equivalent, or permission by the department.

**Required Textbook:** Essential Calculus, Early Transcendentals by James Stewart (2<sup>nd</sup> edition) Cengage with ISBN-13: 978-1-133-11228-0.

**Student learner objectives**: Upon completion of this course, students will be able to:

- Develop solutions for tangent and area problems using the concepts of limits, derivatives, and integrals.
- Interpret and draw graphs of algebraic and transcendental functions considering limits, continuity, and differentiability at a point.
- Determine and explain whether a function is continuous and/or differentiable at a point using limits.
- Apply differentiation rules to differentiate algebraic and transcendental functions.
- Identify and apply appropriate calculus concepts and techniques to provide mathematical models of real-world situations, and to determine and explain solutions to applied problems.
- Evaluate definite integrals using the Fundamental Theorem of Calculus.
- Recognize and articulate the relationship between derivatives and integrals using the Fundamental Theorem of Calculus.

**NOTE:** Math 2113 helps students develop Critical Thinking, Communication, and Empirical and Quantitative Skills by focusing on student understanding of the calculus concepts to include recognizing, identifying, solving, analyzing and explaining appropriately model applicable real-world situations.

- 13. Derivatives and Shapes of Graphs, and Curve Sketching (Sections 4.3-4.4)
