**Course Overview:** This course is a study of the principles and techniques of interpreting, discovering and writing correct mathematical proofs. Students learn to independently prove theorems from various areas in mathematics, which may include topics from logic, the structure of the real number system, number theory, geometry and algebra.

**Prerequisites:** MATH 2313, MATH 2113 with a grade of “C” or higher.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. ### *Students' Rights*
