Catalog Course Description: This foundational course will help students develop an understanding of leadership theory while acquiring the necessary skills and insights to become effective leaders. The course blends theory and application and integrates contemporary ideas and practices with established scholarly research. Students will examine the roles of self-leadership, and the binding relationships between leader and followers. The course considers how power, courage, vision, and morality influence leadership. All class communications will be through Blackboard and students should monitor this several times a day.
- Time Expectation for Coursework: You are expected to spend a minimum of 4-8 hours per week on the course. Based on the background, some students may require more time. Time spent may be longer when assignment/exams are due.

Other Recommended / Reading Materials: Additional reading materials are available on the course website as recommended by the instructor.

#### Course Requirements every student must fulfill in order to succeed in course:

- 1. Students should check the Course Calendar, Announcements, and Messages (email) systems in **Blackboard** on a regular basis.
- 2. Students should stay current with all course assignments, quizzes, and exams.
- 3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.
- 4. Students should ask questions and communicate with the instructor either in class, online, off-line or during office hours.

The final letter grades will be assigned as follows: Above 90% = A; 80 - 89% = B; 70 - 79% = C; 60 - 69% = D; Below 60% = F.

Online Activities: There will be independent learning activities including textbook readings, discussion board, chapter videos, and other items. Students are expected to read the designated chapters and engage in the material presented. To encourage reflection and application, self-assessments will be assigned and discussed through uploaded presentations. BlackBoard will be utilized in this course to assist students with independent learning of the subject.

**Self-Assessments:** These are included in each chapter and students are required to complete their own assessment for indicated chapters and submit them as required in the Blackboard Link on due dates as indicated in the syllabus.

**Student Presentations:** Students are assigned a specific date for a presentation to the class on an assigned topic or question. Be familiar with your computer's microphone and PowerPoint presentation capabilities. Allow approximately 10 minutes for the presentation, include a photo of yourself on the initial slide along with a brief introduction to yourself, fully discuss your topic/question and conclude with at least two (2) meaningful points as addressed in your topic. Schedule and topics for presentations will be posted on BlackBoard/Course Content page, and presentations will be presented by the student on their indicated due date in class. Upload the PP presentation to the designated link in Blackboard by the due date specified on the schedule.

Reflection Paper: The final semester paper will reflect on the totality of the course including assessing yourself as a leader and establishing a plan for improving your leadership skills, based on the semester's self-assessment exercises. As a part of this activity, each student will: develop a personal meaningful definition of leadership, create a personal leadership philosophy, examine their own strengths and weaknesses relative to effective leadership, and draft a personal leadership development plan. Further details and instructions are posted on BlackBoard and discussed in class. All work should be submitted through the respective Blackboard assignment link.

**Case Studies**: Designated case studies are assigned as indicated in the syllabus. Requirements are posted in Blackboard/Course Content.

**Examinations / Quizzes:** Students will be assessed through chapter quizzes which will address the concepts and theories discussed over the semester. The quizzes will be available through **BlackBoard**.

Make up and Late Assignment/exam/quiz policy: As a general rule, make-ups or late submissions will NOT be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extra-ordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

BlackBoard closes at 11:59 pm on the last day of the term, and no assignments are accepted after the due date listed in the syllabus.

Class conduct and civility code: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions in class and online, including the following:

- 1. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
- 2. Student must retain copies of all assignments and graded work for verification purposes and provide it to the instructor, if necessary. Keep your own copies of all computer files and e-mails till final grade is received.

- 5. All assignment submissions must be uploaded to Blackboard by the due date and time. Submission window may close or marked late, even if late by one second.

Class attendance and Participation: Students are responsible for the materials covered in the syllabus. The course covers a lot of material and most students find at least some parts of it difficult. Class participation will be evaluated through discussion boards, presentations to make the class more interesting and enhance the learning experience. Students are strongly encouraged to ask questions, participate in topic discussions and problem solving through your presentations, and visit/contact the instructor during office hours in case of questions or concerns. Good attendance and participation will be rewarded when final grades are assigned.

The course is intensive and challenging and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important, and may vary considerably based on student background. However, a **minimum** of two hours of work outside the class is expected for every one hour of class period per week. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.
