Before we begin, please read this syllabus which provides a roadmap of the semester, outlines course policies and expectations, and provides some tips for improving your chances of succeeding in this course. This syllabus will also serve as a reference throughout the semester which you can consult to answer many of your questions and to guide you towards resources which may be of assistance. By remaining enrolled in this course (choosing not to drop the course), you are agreeing to abide by all course policies set forth in this syllabus.

Course Description

This course focuses on institutional power and constraints. A survey of American constitutional law, using leading cases, both historic and contemporary, of the Supreme Court of the United States. Establishment of the federal political system for which the Constitution provided and the judicial allocations of political and economic power within that system.

Prerequisites: GOVT 2305 and GOVT 2306.

Course Requirements and Expectations

Class Attendance and Participation

Students are expected to log in and complete chapter quizzes each week. Students are expected to have read the assigned material(s) prior to taking exams, and/or quizzes.

Quizzes:

There will be weekly Chapter quizzes except for Chapter 1. Quizzes will open at 12 am Monday morning and are due no later than 11:59 pm cst Sunday night each week. Once the quizzes close, they will not be re-opened as quizzes are not accepted late.

Term Paper:

There will be one Term Paper that will be due later this session or no later than Week 15. Feel free to complete it early but just keep in mind that it will not be accepted late.

Term Paper Information: There is a new social group on the XYZ University campus, Sons of the Republic of Texas, with 100 student members. Each member wears an armband “Sons of the Republic of Texas” at all times while on campus. The group holds meetings in the dorms, student lounge area and outside the Campus Recreation Center (CRC), and other locations on campus open to all students. At these meetings, members openly voice opposition to gays, and at the end of each meeting members use their cell phones to display an image of burned bodies from the holocaust. The University President warned the organizers to stop vocalizing their opposition to the LGBT community and using their cell phones to display an image of burned bodies or the students in the organization will be expelled from the University. Make your strongest argument why the student group should be allowed to voice opposition to LGBT individuals or groups and use the cell phones to display images of burned bodies.

Your paper must be a minimum of 500 words, not including the cover page, abstract, and reference page. **Submit your paper here within the course.** You are to annotate the number of words on the final page. The report shall comply with the APA writing for paper format, abstract, cover page, citations, headings and references. The link to the required APA formatting style is: www.apastyle.org. Go to “Learning APA Style” and to the free tutorial, “The Basics of APA Style.” There is a template attached that you can use as a starting point for your paper. While you may cite to non-academic resources such as Wikipedia, you must cite to at least three (3) *academic* resources (i.e. court opinions, scholarly publications, journals, government reports).

Your grade will be calculated as follows:

25% Analysis supporting your position

25% Citation to relevant academic quality resources

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
