## Course Description

Companion lab to Psychological Research and Statistics 1 covering same learning objectives through a 1 credit hour (3 contact hour) lab.

#### Course Objectives

As a result of taking this course, you will be able to:

- Understand methods and analysis of data from psychological studies.
- Understand fundamental concepts and techniques of both descriptive and inferential statistics and their application to psychological research.
- · Conduct data analyses using EXCEL and SPSS.

#### **G**RADES

Students MUST attend the lab to earn grades on lab assignments. Some assignments are due at the end of class, and some assignments will be submitted through blackboard within 24 hours of the lab meeting. Some instructions/rubrics will be available on blackboard, but some are available ONLY during the lab meeting.

There are 14 labs. Twelve of the labs are worth 10 points each. Two of the labs are online and are worth 5 points each. Your nine highest 10-point lab grades and the two online 5-point lab grades will count towards your final grade. This means that the three lowest 10-point lab grades will be dropped. This generous policy is meant to allow you to maintain a good grade if you are struggling with some lab concepts. Further, it is meant to help you if there are times that you have emergency situations and are unable to come to class. It is important to consider that ALL the information in the R/S 1 lab has been created to support you in the R/S 1 lecture AND to prepare you for the challenging expectations in R/S 2. Try to avoid missing any lab classes so that you can get your full educational experience.

Your final grade in this class will be calculated as a simple average: your points earned on your nine highest 10-point lab grades plus points earned on the two 5-point labs divided by the maximum number of points you could have earned. In this class you can earn up to a total of 100 points.

Grade Cutoffs: A = 90. B = 80. C = 70. D = 60. F < 60.

All written work should be academic quality submitted in APA format in order to expect full credit.

#### LATE WORK

Since labs are completed in-class, late work will not be permitted. If you miss a lab it can be one of the grades dropped.

## STATISTICAL PROGRAMS

What statistical software will we use? Understanding how data analysis software works across different programs is an important and marketable skill. In this course, we will be using both Excel and SPSS.

We WILL use the classroom computers to complete our work. You may want a USB drive or cloud service to save materials because our IT department wipes the computers every night, so if you save anything to the classroom computer, it will not be there after midnight that night.

For Excel, you will need to activate the <u>Data Analysis Toolpak</u>. Most students use the many lab computers around campus that have SPSS, such as in the library or the CAB computer labs (not all have it, but many do). If you would like, you can buy a temporary student license from <u>IBM SPSS</u> affordably. If you want a more permanent solution, there is a free open source clone of SPSS called PSPP (<a href="https://www.gnu.org/software/pspp/">https://www.gnu.org/software/pspp/</a>) that is nearly identical, though if you go this route there may be a few menus that differ and outputs might look slightly different. It hasn't been a huge issue before, but it's worth pointing out. Which program you use is less important than being able to find the information you need in the analysis output.
