Course Description

From the catalog: A survey of general psychology: theories, methods, and basic principles and how these apply to human behavior. Topics include research, the brain, social psychology, learning, memory, and psychological disorders. The course emphasizes the understanding that psychological concepts are derived from the scientific method. TSI Restriction(s): Reading & Writing. Please note that this course is asynchronous.

Course Assignments

Exams:

- There will be a total of four exams each worth 100 points.
- Exams (besides the final) will be administered through Blackboard: as a timed 120-minute consisting of multiple choice and short answer.
- Final Exam will be administered per the university exam schedule.
- Students may not receive any outside assistance while completing either part of their exams.
- Outside of excused circumstances, Exams will not eligible for retake or makeup. If there is a situation, excuse must be valid and presented to professor no later than 24 hours of missed exam. Excused extenuating circumstances must be adhered to the university policies. Failure to complete any exam during the designated testing period **will result** in an automatic grade of 0 being recorded in the gradebook.
- Each exam is worth 15% of students' overall course grade (so 60% of your grade).

Ouizzes:

• During the semester, there will be several quizzes. Quizzes will be administered through Blackboard. Each quiz will have a 20-minute time limit. Each quiz will be open note from class materials and textbook covering lecture and textbook content.

Assignments:

- Throughout the semester, there will be assignments that students will need to complete. Details will be made available via blackboard as assignments become available.
- Writing Assignment: At the end of the semester, there will be a writing assignment due. This assignment is meant to gauge and prepare students writing skills for future classes. Details on assignment parameters will become available.

Class Participation:

• During the semester, there will be several discussion prompts. Students are to respond to the discussion prompts as well as to **1 peer**. Students are to be professional, courteous, and on topic. Any discriminatory, hateful, and disrespectful writing will not be tolerated and reported.

Research Experience Credits (SONA): 6 point per 1 hour credit; 30 points total

- Psychology is the scientific study of the mind and behavior. Because Psychology is a science, students
 in several classes at A&M-SA have a Research Experience Component (REC), which allows students to
 gain first-hand knowledge of the scientific methods that psychologists employ. The REC is designed to
 help students gain a more complete understanding of the process and outcomes of psychological
 research.
 - o To complete the Research Experience Component (REC) requirement for this course, you will have to complete the assignment described below:
 - Requirements:
 - The REC is worth 5% of your final grade and each student must earn a minimal of 5 credits (1 credit = 1 hour of research participation).
 - All credits must be completed by the last day of classes on May 5th, 2025.
 - Students may earn credits by mixing and matching between several different options listed below (see next page for Options 1, 2, and 3):

- Option 1: Participating in Psychological Research (SONA).
 - Studies are conducted by faculty in the Psychology Program and approved by Texas A&M University-San Antonio's Institution Review Board. You will complete consent procedures before every study, and you have the right to withdraw from any study, at any time, without penalty. You must be 18 years old or older to participate in research studies.

o FAQ about Option 1:

- The number of credits for each study varies. For example, some studies may be worth 5
- credits, 1 credit, or 0.5 credits, etc.
- Access to approved studies is provided at https://tamusa.sona-systems.com
- Studies will be available to participate in after census day. It is your job to check SONA for studies, to complete the studies, and then to complete any additional assignments required to earn credit.
- Studies may be in person or online. If a study is in person, SONA lists the time and place where the study will be conducted. If a study is online, SONA lists the DEADLINE by which you must complete your participation. Also, credit for online studies will be posted AFTER the deadline passes. The last day to participate in a study for credit is the last day of the term (prior to reading days and finals).
- Option 2: Reading Published Psychological Research.
 - Each research article summary equals 1.00 credit.
 - If you elect to use Option 2 to gain some/all of your REC credit, you will need to select an APA paper from you own research or ones suggested to you. You can email your instructor for guidance on what's appropriate. You will read the article on your own then afterwards, you will write a reflection paper. This paper summarizes your understanding of the article and your analysis of the paper.
 - Your paper should include all of the following:
 - o A short summary of the paper.
 - A deeper, more extensive outline of the main points of the paper, including for example assumptions made, arguments presented, data analyzed, and conclusions.
 - o Any limitations or extensions you see for the ideas in the paper.
 - Your opinion of the paper; primarily, the quality of the ideas and its potential impact.
 - The paper should be two pages long—not shorter, not longer. Use APA format.
 - Please email your work directly to your instructor. The assignment should only be in Word or PDF format. This assignment is due on the last day of classes, before finals week begins.
- Option 3: Attending Psychological Research Presentations.
 - Students may attend an oral presentation over a psychological research topic.
 Students can seek out and attend presentations given through university-sponsored events, (e.g., Psychology Speaker Series, College of Arts & Sciences

Faculty Speaker Series), and academic conferences (e.g., Southwestern Psychological Association, TAMUSA Sponsored Research Conference).

- FAQ about Option 3:
 - To earn credit through this option, students can sign up for presentations that occur on campus via SONA Systems (same way they would for Option 1).
 - o If you are attending a presentation/conference outside of TAMUSA, email your instructor for additional instructions.
