COURSE OVERVIEW

How does the brain produce behavior? This course explores the underlying mechanisms of behavior, taking a look “under the hood” to help us understand behaviors like sensation, perception, learning, intelligence, social behavior, and more. We’ll look at the behaviors from the perspective of the brain circuitry, hormones, genes, neurotransmitters, and more to understand behavior.

COURSE GOALS AND OBJECTIVES

As a result of successfully completing this course, the student will be able to:

- Design a teaching tool to explain to the general public how a neuron works, including how neurons communicate and how the brain uses electrical signals
- Make informed decisions about the ethics of animal research, including policy recommendations and educating members of the general public
- Identify ways in which culture and language can influence perception, brain development, and cognition
- Provide a nuanced view of the study of human intelligence, using the current literature on general cognitive ability to take an evidence-based stance while maintaining cultural sensitivity.

GRADING

Assignments. There will be five assignments worth 5 points each.

Exams. There will be five exams consisting of a mix of multiple choice and short answer, 15 points total. Plan for these to be timed and completed in one sitting.

The total points for the course is 100. You can take your final total and calculate the percentage and letter grade based on the usual cutoffs (90 = A, 80 = B, 70 = C, 60 = D, 59 or lower = F).

LATE WORK

Due dates and times are clearly listed on every assignment. In general, work for the week is due at midnight on Saturdays. Work turned in after the due date and time is considered late and will not be accepted. If you have an emergency situation, notify me ASAP for consideration, and include any necessary documentation.

TIME COMMITMENT

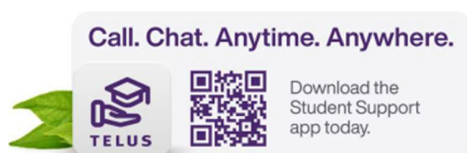

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR

668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
