

**Course Description**

Directed Research. Variable credit: 0-3

Individual instruction course for advanced and qualified undergraduates to obtain supervised research experience in psychology. Student will assist with a research project by working under the individual guidance of a psychology faculty member. Requirements may entail library research, data collection, data entry, statistical analysis and or assistance in planning and conducting parts of a research project. A paper on the research experience is required. Consent of instructor required. Variable credit for a total of 6 maximum. Prerequisites: PSYC 2301, PSYC 2388.

**Objectives**

As a result of taking this course, you will be able to:

- Get hands-on experience in data collection and analysis
- Find and summarize literature related to a specific research topic of interest
- Create materials for data collection
- Prepare to present research studies to the world

**Lab Meetings**

We will have regular meetings throughout the semester to discuss progress on deliverables, assess the status of projects, and help make sure everything is running smoothly.

**How your grade will be determined**

Each student will work with Prof. Daniel to create a list of deliverables for the semester. Your grade will be based upon the number and quality of deliverables accomplished. The total number of points for all deliverables will be 100, and grades will be determined as follows:

**A = 90-100 Points**

**B = 80-89 Points**

**C = 70-79 Points**

**D = 60-69 Points**

**F = 59 and fewer Points**

Students will be expected to participate in all aspects of the class. Missing meetings and missing deadlines will result in a lower grade. In addition, students are expected to keep track of their hours spent on class work if they are in the 1, 2, or 3-credit sections. That will be turned in twice a semester, or once in the summer.

Volunteers (PSYC 4051) will not need to do this. They are, however, expected to attend all meetings. A final project deliverable will also be necessary for assessment, for students taking the course for 1, 2, or 3 hours of credit.

**Time Commitment**

Federal law mandates that each “hour” of course credit requires two hours outside of class. As such, we expect three hours per week of activity related to the course for each hour of credit. This includes time spent in scheduled lab meetings, finding and reading articles, preparing presentations, and so on.

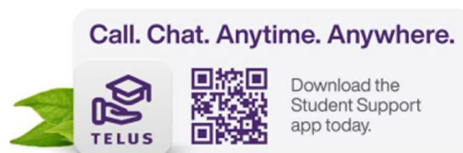

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Writing, Language, and Digital Composing Center: The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

#### *Students' Rights*

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution.
2. Each student shall have the right to participate in all areas and activities of the University, free from any form of discrimination, including harassment, on the basis of race, color, national or

4. Each student subject to disciplinary action arising from violations of university students' rules shall be assured a fundamentally fair process.

### *Students' Responsibilities*

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
