COURSE DESCRIPTION

PSYC 5304 Capstone Project

Credits: 3 (3-0-0)

All graduate students who are not completing a thesis will be required to complete a capstone project. Students will complete a comprehensive literature search and effectively synthesize published research in a major area in psychology. The project applies knowledge and skills learned in the courses that comprise a student's degree program. Ultimately, the project will culminate in a well-written and thorough analysis of current state of research in a major area of psychology. .

Prerequisites: [PSYC 5301](#) and [PSYC 5302](#) with a grade of B or better.

Restrictions: Enrollment is limited to Graduate level students.

OBJECTIVES

This course is intended to devote time to capstone or thesis projects. This includes creating project ideas, refining experimental designs, literature reviews, conducting research, data analysis, preparing for defenses of proposals and final projects, presentation of results at professional conferences, etc.

Projects will vary by student and will require working closely with their faculty advisor. The project will likely span multiple semesters. However, the expectation is that the final project will be a scientific contribution that is publishable in a peer-reviewed journal.

Performance and grading will be determined by assessing whether appropriate and significant progress has been made toward this goal from the start to the end of the semester.

GRADED ELEMENTS

30% Capstone Project Proposal – Written elements. Literature review, methods, data analysis plan/results, discussion, required APA style elements.

15% Capstone Proposal/Defense – Oral Presentation. May occur at any time during the semester, but earlier is better. Please work with your advisor and committee to ensure that you are on track.

15% Conference Participation – Must apply to present and must attend at least one scholarly conference. Fall: ARMADILLO, Psychonomics, or Society for Neuroscience. **Spring: Southwestern Psychological Association (SWPA) or The Southern Society for Philosophy and Psychology (SSPP).** Other conferences may serve at the discretion of the faculty advisor.

*Note: Full participation at the conference is expected. It is rude to present during your time slot and then leave; part of the importance of conferences is networking and learning what other scientists are doing and how it integrates with your work.

**Note: If you need financial support to offset the costs of registration or travel, please contact your faculty advisor. We have mechanisms to assist with this, such as manning a booth for a portion of time at the conference for discounted registration costs.

25% Planning Meetings with Advisor.

10% Student Research Symposium on campus. Participation is mandatory. Similar to conferences, you should plan to present and stay for at least your full assigned session and attend the keynote address.

5% Participation in Psychology programming (psychology lecture series, guest lunches, etc).

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. **Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI.** If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. **Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.**

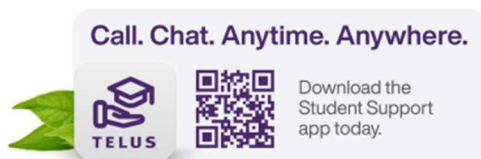

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the

student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Writing, Language, and Digital Composing Center: The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. Tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable modifications to pregnant students as would be provided to a student with temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution.
2. 4. Each student subject to disciplinary action arising from violations of university students' rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, Student Code of Conduct, on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
