COURSE DESCRIPTION

From the catalog: This course is designed to allow the program to add a specialized course that fits the needs and requirements of the cohort of graduate students but will not be a permanent elective course topic. Special topics courses allow the students and faculty to explore current new topics in the scientific field, to focus specialized training on a particular psychological subfield, and/or provide specialized training in a unique subfield/topic that is currently not an elective.

REQUIRED TEXTS

- You will be provided with supplemental readings through Blackboard that will help you understand different topics.

OBJECTIVES

- Design experiments with statistics in mind
- Become proficient in using software for statistical analysis
- Identify best practices and common misuse of data
- Apply the appropriate statistical tests to novel data sets
- Have broad familiarity in statistical approaches to different kinds of data from broad disciplines in psychology

LATE WORK

In general, **work for the week is due by class time on Friday of the following week.** Work turned in after the due date and time is considered late and will not be accepted. No exceptions. Graded Items:

Faculty Section Reflections

At the end of each faculty section, you will submit a reflection that covers a) a general, short overview of what you learned about the faculty member's research area (no longer than 1 paragraph), b) a possible research question that could be pursued within that research area, and, 3) how you see your relationship with this faculty member progressing over the course of your graduate career and beyond (e.g., thesis advisor, thesis committee member, capstone advisor, course professor)

Course Experience Reflection

At the end of the semester, you will submit a reflection that includes a) a general description of a research area in which you take most interest, b) one or two possible research questions that you would like to pursue, and c) the individuals (and their roles) who you will ask to serve on your thesis committee or capstone experience.

Each of the five reflections is worth 20 points.

QUALITY OF WRITTEN WORK

All written work should be academic quality submitted in APA format in order to expect full credit.

WITHDRAWAL POLICY

Any withdrawals after the last day for an automatic "W" date established by the university will receive the grade of "F".

AI POLICY: USE OF GENERATIVE AI PERMITTED UNDER SOME CIRCUMSTANCES OR WITH EXPLICIT PERMISSION

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended the first week of class.
