### **COURSE DESCRIPTION**

The focus of this seminar is the examination of development during childhood (infancy through middle childhood), including biological, cognitive, social, emotional, and cultural aspects. The seminar will focus on theories, research, and applications for everyday interactions to garner appreciation and understanding of normative and nonnormative patterns of development. The goals of this seminar are (1) to understand the mechanisms that shape development during childhood and (2) to articulate, critique, and defend theoretical, empirical, and applied positions concerning the nature of development.

### **REQUIRED COURSE MATERIALS**

- **Assigned Readings:** All assigned readings will be posted on Blackboard weekly and made available at least one week before the scheduled topic listed in the course calendar. Students are expected to complete the readings in advance of the class session in which the material will be discussed.

### **CONTACT GUIDELINES**

I will strive to be available to aid your learning process by providing several ways to contact me:

- **Email:** Please only use official university e-mail and include the course, section, and full name in the subject line. Please do not use Blackboard messages. The email noted above is my primary and preferred point of contact outside of the classroom.

I will check my email regularly on Monday – Friday from 8:00 am to 5:00 pm. I will generally respond within 24 hours of your email. If you do not receive a reply after 24 hours, please email again and/or follow up directly with me in class or during office hours (see above). I will not be available by email during the weekends. Any emails received during the weekend will be replied to on the subsequent Monday. Please plan accordingly. Especially when it comes to clarifying assignment instructions and/or submission requirements.

In all communications, please be professional in your tone and specific in your message (i.e., avoid informal correspondence styles like text messaging which lack appropriate punctuation and capitalization). Your correspondence MUST include the information specified above. If you send an email without sufficient information, I likely will not reply or may reply asking for clarification about your inquiry (this can result in an unnecessary delay). Please begin a new email thread instead of responding to older emails if you are beginning a new conversation unrelated to the previous email (this helps minimize confusion caused by chain replies).

- **Office Hours:** I will be available in my office (STEM 249B) to meet during office hours (see above) or by appointment. Office hours are dedicated to interacting with and providing students assistance regarding coursework. An appointment is not necessary to attend these hours, but interactions are limited to a first-come, first-served basis. If there is a specific assignment/materials or topic you want to discuss, providing advance notice will allow me to have these resources ready. If students cannot meet during these times, an alternative time can be requested via email, and I will do my best to try to accommodate students accordingly. For discussions involving more personal and/or sensitive information, some form of advance notice is recommended.

### **ASSESSMENT & EVALUATION**

All assignments will be administered from and turned into Blackboard. No paper copies will be accepted unless otherwise noted. Late work will not be accepted without a university-approved excuse and/or advance notice with instructor approval. Additionally, you are expected to complete all work independently (see Academic Integrity section for more details on independent work).

The following descriptions are intentionally brief. Detailed instructions will be available in class and through Blackboard throughout the semester. Each assignment will have a specific set of instructions students will be required to follow.

- **Weekly Discussion Questions – 10 points.** Each week, students must submit two discussion questions (combined worth 1 point) based on the assigned readings at least 24 hours before class. These questions should demonstrate critical thinking, moving beyond surface-level observations. The discussion questions can be related to theory, methodology, and/or application.
- **Student Led Sessions – 10 points.** Each student will facilitate a 45-to-60-minute conversation based on the week's assigned readings and may incorporate supplemental material (e.g., media clips, brief activities). Detailed instructions for the student led sessions (e.g., format, length) and rubric will be posted on Blackboard.
- **In-Class Activities – 15 points.** There will be three graded in-class activities (worth 5 points each) on the dates noted in the course schedule. The topic/format of these activities will depend on the content for the week. Attendance and active participation are required.
- **Midterm (Policy Brief) – 30 points.** Students will write a policy brief that translates research on a specific developmental issue (e.g., child maltreatment) into

applied/practical recommendations for policymakers, educators, or service providers. Detailed instructions for the midterm (e.g., format, length) and rubric will be posted on Blackboard.

- **Final (Research Proposal) – 35 points.** Students will develop a research proposal that addresses a specific developmental psychology research question (e.g., identity development in adolescence). Detailed instructions for the final paper (e.g., format, length) and rubric will be posted on Blackboard.

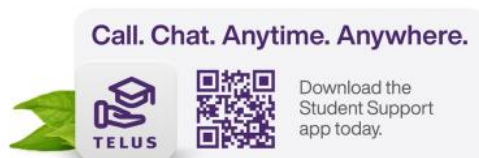
### **COUNSELING/MENTAL HEALTH RESOURCES**

## **FINANCIAL AID AND VERIFICATION OF ATTENDANCE**

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
