Course Description

El curso tiene como objetivo permitirle al estudiante con un nivel avanzado de aprendizaje del español, el desarrollo de su expresión escrita. El curso se diseñó para que los estudiantes profundicen su conocimiento gramatical y amplíen su léxico. A través de lecturas, ejercicios y práctica intensiva, los alumnos trabajarán diferentes técnicas y estilos de prosa. Todas las sesiones se desarrollarán en español aunque el *translenguaje* es permitido dependiendo del contexto.

Los objetivos principales del curso son:

- (1) madurar habilidades escritas a nivel formal,
- (2) repasar estructuras gramaticales de los textos en español,
- (3) ampliar el vocabulario activo y
- (4) seguir mejorando el español conversacional.

Las clases se dedicarán a la corrección y discusión de los textos, y el repaso de las tareas. Los estudiantes deben de estudiar con cuidado los textos, el vocabulario, gramática y preguntas antes de llegar a clase. La preparación y participación activa es un requisito esencial para que la clase tenga éxito. La asistencia de por sí no forma parte de la evaluación de la preparación y participación en clase (claro está que la una no se puede evaluar sin la otra).

Reading and Writing Goals

- 1. To read and think closely, creatively, analytically, and innovatively.
- 2. To articulate a clear, critical thesis in an introduction.
- 3. To support a thesis with relevant and varied forms of evidence and sustained critical analysis.
- 4. To substantially revise one's own writing using instructor comments and peer reviews.
- 5. To craft sentences and paragraphs which demonstrate correct and effective mechanics, grammar, usage, and style.
- 6. To begin to develop creative and novel ways of framing an argument, and to engage multiple points of view, distinct audiences, and interdisciplinary perspectives.

Las instrucciones para cada composición se darán en clase según el calendario del curso. Cada ensayo deberá ser de 2.5-3.5 páginas (double espacio) redactadas durante los talleres. Las composiciones serán evaluadas tanto por su precisión gramatical y ortográfica, como por su contenido, enfoque y organización.
