# **Course Description**

This course is an introduction to photography for the general student and assumes no prior experience in photography. Through the development of critical thinking and technical skills, students will learn how to visualize, create, and evaluate photographic images. Techniques covered will include basics of camera operation, digital photo editing, photographic genres, and introduction to critical and theoretical practices. In addition to studio practices such as technical demonstrations, studio assignments, group critiques, and collaborative assignments we will also engage with photographic theory through readings, presentations, and discussions.

# **Learning Outcomes**

# Upon successful completion of this course student will...

- Be familiar with basic camera operation including shutter speed, aperture, ISO, white balance, focus, etc.
- Understand photographic genres and their conventions.
- Be able to work collaboratively in the production and exhibition of photographic images.
- Be able to participate in constructive criticism and implement those critiques in their own work.
- Have a basic understanding of the history of the photographic medium.
- Have a basic understanding of the critical discourse and theory formed by and around the photographic images.

# **Course Assignments**

## **Weekly Photography Assignments: 70%**

Each week you'll be required to take at least 100 pictures. This may sound like a lot but with digital technology it will go more quickly than you might think. It's also important to take a lot of pictures because photography, like all arts, is a practice. For each assignment I'll provide an assignment sheet with a rubric explaining what's expected in the assignment and giving tips about how to be more successful. At each stage of your assignments you'll post images to your TAMUSA OneDrive so that I can review them to calculate your grades.

## **Notes: 10%**

Class notes are designed to help you keep track of key information, organize class content and support classroom activities. Notes will be required in response to classroom lectures and demos, and content that you engage with outside of class, for example artist videos. It is important to develop a practice of note taking during these experiences because notes are a valuable resource which you can refer to and refresh your memory. They encourage you to be an active recipient of information.

## **Classroom Discussions, Presentations and Experiments: 10%**

Starting week 4, students will be presenting different experimental techniques. The presentations will outline some historical and contemporary examples of the technique, a basic how-to demonstration and a class written class assignment. The rest of the class will be dedicated to experimenting with the technique. 50% of this grade is based on your presentation and 50% is dependent on participation in the class experiments presented by other students.

## Final Project: 10%

For our final project, we will be exploring the creative process itself. We will consider convergent vs divergent thinking, top-down vs bottom-up production, and the relationship between control and chance. Each step of this project will be revealed as we go.

# **Grading & Attendance**

Work is primarily based on completion and engagement. You do not need prior knowledge of art and photography to do well in this class. You will need to participate in classroom activities, complete outside of classwork, and show the ability to use feedback productively.

#### **Late Work:**

- For the first half of the semester, projects will be accepted for full credit any time before midterm as long as the student is demonstrating a continued effort.\* In the second half of the semester, projects will be accepted for full credit at any time before our final class meeting (the last class before finals week), again as long as the student is demonstrating a continued effort.\*
- Student can lose up to 15% credit for each studio day missed during a project.

\*Continued effort is defined as ongoing communication with the instructor and evidence of work being completed.

### **Attendance:**

- You will be able to accrue 4 absences without penalty in this class.
- After 4 absences, each additional absence may drop your final grade by up to 5%.
- Students have 7 or more absences are advised to drop this course to protect your GPA.

## **Basic Expectations:**
