Course Description and Material

Catalog Description: Systems of linear equations, matrices, determinants, vector spaces, eigenvectors, eigenvalues, orthogonality, linear transformations and their representations by matrices, and applications.

Prerequisite: Math 2313 and Math 2113 with a grade of "C" or higher.

Required Textbook: Linear Algebra and Its Applications by David Lay, Steven Lay, and Judi McDonald (the 6th edition), with MyLab Math. Pearson Publishing with ISBN-13: 9780135851159.

NOTE: Please find the instructions on the Blackboard for the registration.

Other Materials: Scientific calculators can be used for in-class activities, and TI-30XIIS is recommended.

NOTE: TI-83 or higher calculators, laptops, cell phones, and any other electronic/mobile devices will **NOT** be acceptable for the tests/exams.

Student Learning Objectives: The course explores the fundamental concepts and principles of linear algebra with applications, and students who successfully complete the course will:

- Demonstrate an understanding and working knowledge of matrices and vectors.
- Formulate and solve problems requiring the application of matrices, linear transformations and their properties.
- Exhibit a basic proficiency in determining and explaining linear algebraic structures and their analytic and/or geometric interpretation.
- Demonstrate a basic understanding of the underlying principles of vector spaces.
- Write clearly about linear algebra concepts to include definitions, counterexamples and simple proofs.
- Apply linear algebra to model basic geometric, biological or physical problems.

List of Topics: In particular, students who successfully complete this course will be able to demonstrate an understanding and working knowledge of:

1. Linear Equations in Linear Algebra (Sections $1.1 \sim 1.4, 1.6 \sim 1.8, 1.10$)

Test 1 covers Chapter 1 (only selected important topics).

- 2. Matrix Algebra (Sections $2.1 \sim 2.2$)
- 3. Determinants (Sections $3.1 \sim 3.3$)

Test 2 covers Chapters 2~3 (only selected important topics).

- 4. Vector Spaces (Sections $4.1 \sim 4.3$)
- 5. Eigenvalues and Eigenvectors (Sections $5.1 \sim 5.4$)

Test 3 covers Chapters 4~5 (only selected important topics).

6. Orthogonality and Least Squares (Selected Sections $6.1 \sim 6.6$)

Final exam covers Chapters 1~6 (only selected important topics).

The instructor reserves the right to modify/update the topics as appropriate.

NOTE: This class meets twice a week. Aside from the three hours that you spend in class each week, you should devote at least another 4~6 hours to studying on your own: reading the book and my lecture notes, working out your homework assignments, and solving some extra related problems for practice etc. You are responsible for all materials/topics discussed in this class.

Active Learning: This course incorporates active learning throughout. You are strongly encouraged to preview the teaching materials in advance and be prepared for frequent class participation as well as individual and group learning activities.

Course Expectations and Requirements

Class Attendance: You are expected to attend classes as scheduled and be prepared to participate in discussions, in-class exercises, and problem presentations. Attendance is taken in each class and it will contribute to your final grade. Each student is allowed up to 3 absences for the duration of the course, any further absences will affect your final grade. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, please minimize class interruption.

Examinations: There will be three midterm tests during the semester held in regular class: one in Sep, one in Oct, and one in Dec, and there will be one comprehensive common final exam at the end scheduled on Monday, 12/8/2025, 2:00pm-3:50pm.

Exams are scheduled at specific times, and you are expected to take them as scheduled. If you cannot attend an exam for a legitimate reason, please let me know (or have someone notify me if you're unable to) within 24 hours of the scheduled exam time. You will need to provide a brief explanation along with appropriate supporting documentation. If you know ahead of time that you will miss an exam, please contact me in advance so we can make the necessary arrangements. Missing an exam without following this procedure may result in a **GRADE OF ZERO**.

Dates of Midterm Tests: The exact midterm test dates will be announced at least one week in advance, both on Blackboard and by email. All tests will be taken during class time.

NOTE: Graphic calculators, cell phones, laptops, iPad, and any other electronic/mobile devices are **NOT** allowed in tests/exams. Once found, your tests/exams would receive **GRADE OF ZERO**. Repeated violations may be reported to the university as academic dishonesty.

Assignments: All homework assignments will be completed online in MyLab Math. Please check Blackboard announcements for instructions and due dates. If you cannot finish every question, do your best to complete as many as possible. Don't wait until the last day to start, as working on problems daily will help you stay on track. You may attempt each homework assignment multiple times to improve your grade.

You may have group/team discussions on homework assignment problems. However, you must write up the solutions on your own and truly understand the mathematics/algorithms involved. Be mindful of your academic integrity.

Presentations/Debates: Students will be expected to participate in class by presenting/debating problems emphasizing the most recently covered topics that are related to and complementing HWs.
