**Course Description and Materials**

**Catalog Description:** The course explores fundamental concepts in elementary number theory to include divisibility, congruence relations, rational integers, Diophantine equations, quadratic reciprocity, Fibonacci numbers, and related topics.

**Prerequisite:** Math 3325: Introduction to Mathematical Proofs or Math 3370: Discrete Mathematics, with a grade of “C” or higher.

**Required Textbook:** Elementary Number Theory (7<sup>th</sup> Edition). David Burton. Springer. ISBN-10: 0073383147, ISBN-13: 978-0073383149.

**Learning Outcomes:** Upon completion of this course, you will be able to:

1. Effectively express the concepts and results of Number Theory.
2. Construct mathematical proofs of statements and find counterexamples to false statements in Number Theory.
3. Understand the logic and methods behind the major proofs in Number Theory.

## Course Expectations and Requirements

**Examinations:** Exams are scheduled at specific times, and you are expected to take them as scheduled. If you cannot attend an exam for a legitimate reason, please let me know (or have someone notify me if you're unable to) within 24 hours of the scheduled exam time. You will need to provide a brief explanation along with appropriate supporting documentation. If you know ahead of time that you will miss an exam, please contact me in advance so we can make the necessary arrangements. Missing an exam without following this procedure may result in a **GRADE OF ZERO**.

There will be two midterm tests during the semester: one in Oct, and one in Dec. The exact test dates will be announced at least one week in advance, both on Blackboard and by email.

Test 1 covers Chapters 1~6 (only selected important topics).

Test 2 covers Chapters 7~13 (only selected important topics).

**Assignments:** There will be 7 homework assignments, with due dates posted on Blackboard. Please submit each assignment as **one combined PDF file** through Blackboard. Your work should be neat and legible. Clear, well-organized solutions will not only make grading easier but will also serve as helpful study notes when you review. Be sure to show both your answers and the steps leading to them; credit will **NOT** be given for answers without supporting work.

**Presentations:** Each student will be required to give a monthly presentation focusing either on significant mathematical theorems or selected homework problems. These presentations are designed to foster a deeper understanding of key concepts, promote critical analysis, and improve communication skills by encouraging students to explain complex ideas clearly and engage with their peers through constructive feedback.

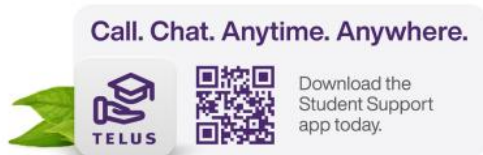

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
