Course Description:

This 3-hour course will explore the various disorders that often co-occur with respect to substance use/misuse and behavioral disorders. The course will also cover the history of co-occurrence (or dual diagnosis) and treatment. In addition, the challenges with addressing each both dependent and independent of one another.

Student Learning Outcomes:

At the successful completion of this course:

- Students will demonstrate general knowledge of co-occurring disorders and dual diagnoses in minors and adults.
- Students will be able to identify evidence-based screening and assessment instruments to use with dual diagnoses, specifically in reference to substance use disorders
- Students will demonstrate knowledge about the characteristics and utility of various approaches and interventions related to the treatment complex diagnostic presentations
- Students will demonstrate knowledge related to various environments of encounter and support with cultural competencies related to the treatment of individuals with co-occurring disorders, such as hospital systems, criminal justice systems.

Description of Course Assignments

All assignments are due on Fridays by midnight central standard time and submitted online via Blackboard, unless otherwise noted. Questions should be asked ahead of the due date either during class, office hours, or via email.

Attendance

Since this is a Human Services course, your attendance is measured by engagement with each other, and the course material. Blackboard analytics provides a generous monitor of clicks, session duration and other insights to help faculty determine student interaction with the learning material. While attendance does not serve as a grade in this course, it is taken to meet University reporting standards.

Discussion Video Chats Format:

You will be randomly assigned to a group. The group will meet online via Microsoft Teams at a day and time mutually agreed upon between group members. Each week, one student will send the Teams meeting invitation, begin the meeting, and ensure the meeting is recorded. Please be respectful, and choose whatever works for your group dynamic. The student will record a 15–20-minute video chat wherein all students within the group will reflect on the week's material and

any supplemental material they have reviewed. Once the meeting is concluded, locate the meeting transcript in your OneDrive. Then upload a copy of the transcript into the assignment opened in Blackboard.

There is a How-To Guide for this assignment with detailed information on using Microsoft Teams for this purpose.

Your individual grade will be based on your participation within the group as reflected in the transcript that you upload. Each video chat is worth 5% of your overall course grade, and there are a total of four video chats this semester, producing 20% of your overall course grade.

Mid-Term Examination

Your midterm examination will consist of 30 multiple-choice (2 points each) and 4 short answer (10 points each) items from chapters 1-10 of your textbook, in-class lecture material, and slides. This exam will be open for 24 hours, via Blackboard. The exam is worth 20 (20%) points toward your overall course grade.

Article Review

This week you will use the library databases to identify and review a peer-reviewed journal article from a relevant, peer-reviewed journal (example: the *Journal of Human Services*) that reports the findings of primary research regarding a serious mental illness (abbreviated SMI; PTSD, Major Depressive Disorder, Schizophrenia etc.) AND a substance use disorder of your choice. Choose an article published within the last 5 years and reflects your personal interests. **Do not use a meta-analysis.** Use 5 paragraphs to articulate:

- Paragraph 1: Introduction of the article that includes a brief 1-2 sentence summary of the article along with 3-5 sentences about the background/history of the topic and rationale for the study
- Paragraph 2: Identification and description of the method that was implemented (hint: if there's not an identifiable 'methods' section, you are not looking at original research).
- Paragraph 3: Review of the key findings and how those align with the author(s) research questions and hypotheses
- Paragraph 4: Identification of limitations and how these might be improved upon
- Paragraph 5: Your impressions of the practical value of the study for informing practice

Your submitted document should include an APA-formatted title page, main text, and reference page(this includes within-text citations, and a reference list citing the article selected, as well as any other unoriginal material you cite). This assignment is worth 15 (15%) points toward your overall course grade.

BONUS POINTS: Students who complete the <u>TAMUSA Library's Modules and Quiz</u>, "What is a Literature Review" will earn two bonus points on their submitted paper. This may not sound like a lot, but on a 15-point assignment, it can change a letter grade. Submit a screenshot of your quiz completion along with your paper.

Case Study Assignment

You will be individually assigned a case synopsis from which to formulate a thorough case conceptualization, that will be created in an engaging, impactful PowerPoint or similar presentation format and presented during class. This should include:

- Slide 1: History & Biopsychosocial evaluation
- Slide 2: Presenting Concerns and identification of dual-diagnoses/disorders
- Slide 3: Screening & Assessment(s). <u>You must include the Columbia Suicide</u> <u>Severity Rating Scale (C-SSRS) that is most applicable to your client.</u>
- Slide 4: Suggested Interventions and available resources for support
- Slide 5: Summary of Care

Slides will be due via blackboard assignment submission. You will then present your case study in class on a separate day. Your assignment is worth 20 (20%) points toward your overall course grade. While you may work together/collaborate, you must attribute any unoriginal work to its appropriate source or author, and attend to your individual's synopsis.

Final Examination

Your final examination will consist of 30 multiple-choice (2 points each) and 4 short answer (10 points each) items from chapters 11-17 of your textbook, in-class lecture material, and slides and is worth 25 (25%) points toward your overall course grade.

A non-punitive drop does not affect the students GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated agrades and will impact the students GPA.

Incompletes

The spirit of the "Incomplete" is to give a student an opportunity to complete a course after the end of the semester. An Incomplete will only be considered under specific circumstances: 1. 70% of the class has been completed and student is passing with a "C" or better 2. The circumstance for which the "I" is requested is supported with documentation 3. Student has been attending class on a regular basis Incompletes are not to be used to remedy excessive absences. Unforeseen circumstances precipitating the request for an "I", should occur near the end of the semester. Students who are experiencing difficulties at the beginning or midway through the course should contact their professor immediately to discuss options. When a professor agrees to grant an "I", a contract between the student and professor that outlines a specific timeline for completion of the course will be generated. Topics such as highest possible grade will also be outlined. If the contract is not fulfilled, the professor will submit a change of grade form with earned letter grade. All "I"s will automatically revert to an "F" after one year.

Dropping a Course
