Time and Place of Class Meetings:

BIOL 4305 is not a traditional lecture-style course. There will be a standing biweekly laboratory meeting that the student will be expected to attend. The time and place of research participation will depend on the research being performed and the availability of the student.

Description of Course Content:

Students enrolled in BIOL 4305 will gain experience in research as a member of The Watson Lab by taking a major role in a research project alongside the PI or a graduate student. Students are expected to attend the biweekly laboratory meeting and spend a minimum of three hours per week working in the laboratory. A product, such as a research poster or manuscript, will be produced by the student and may be presented at a local or regional scientific meeting.

Student Learning Outcomes:

1. Working as part of a team to perform biological research.
2. Designing and implementing a research plan
3. Data collection and management
4. Skills in ecological and/or physiological research techniques
5. Understanding the process of science from observation to publication.

Recommended Textbooks and Other Course Materials:

Reading materials will be assigned and distributed at laboratory meetings and/or posted on Blackboard.

Blackboard:

This class uses the learning management system Blackboard Ultra to disseminate content and information. I will post links to videos, notes, reading materials, digital supplements, and announcements from this learning platform.

Grading Policy:

Grades will be assigned based upon attendance and contribution in meetings, weekly research participation, and the quality of the poster or manuscript produced. Students start out with full credit (100%) and every missed laboratory meetings will result in a reduction of one letter grade (-10%). The research product will constitute 50% of the student's grade.

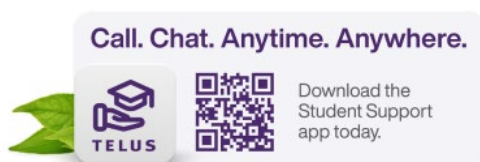
Counseling/Mental Health Resources:

Financial Aid and Verification of Attendance:

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Writing, Language, and Digital Composing Center:

The Writing, Language, and Digital Composing Center supports graduate and undergraduate students in all three colleges as well as faculty and staff. Tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. The Six-Drop Rule:

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students:

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable modifications to pregnant students as would be provided to a student with temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities:

The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights

1. A student shall have the right to participate in a free exchange of ideas, and there shall be no University rule or administrative rule that in any way abridges the rights of freedom of speech, expression, petition and peaceful assembly as set forth in the U.S. Constitution.
2. 4. Each student subject to disciplinary action arising from violations of university students' rules shall be assured a fundamentally fair process.

Students' Responsibilities

1. A student has the responsibility to respect the rights and property of others, including other students, the faculty, and administration.
2. A student has the responsibility to be fully acquainted with the published University Student Rules found in the Student Handbook, [Student Code of Conduct](#), on our website, and University Catalog, and to comply with them, as well as with federal, state, and local laws.
3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
