EXERCISE CRITICAL THINKING SKILLS IN ASSESSING THE WAYS IN WHICH GENDER AS A SOCIAL CONSTRUCT INFLUENCES THE SOCIAL, CULTURAL, PHILOSOPHICAL, ECONOMIC, AND POLITICAL DIMENSIONS OF THE HUMAN EXPERIENCE IN SOCIETY.

DEMONSTRATE AN UNDERSTANDING OF INTERSECTIONAL GENDER STUDIES, AS WELL AS THE CONSEQUENCES—POSITIVE AND NEGATIVE—THESE INTERSECTIONS HAVE FOR LOCAL, REGIONAL, NATIONAL, AND GLOBAL COMMUNITIES.

#### COURSE DESCRIPTION

This course introduces students to the interdisciplinary field of Women's and Gender Studies, drawing from a range of diverse disciplines, such as History, Philosophy, Literature, Political Science, and Sociology. It covers the origins of the field, as well as significant themes, ideas, and conceptual frameworks. This course will also provide a foundation for future courses in Women's and Gender Studies.

This is a hybrid course with required weekly in-person meetings AND asynchronous online components.

### COURSE EXPECTATIONS

PARTICIPATION AND COURTESY: Discussion is an important part of this course, and we will not always agree. All points of view are welcome, as long as they are informed (meaning, you have done the required reading for class) and are not deliberately discriminatory. Your participation helps you develop your own skills, while encouraging your peers to develop theirs. Do the readings, get your work done, and be excellent to each other.

ATTENDANCE: Attendance in this class is imperative. Changes to the syllabus, advice, and feedback will be given in class and via Blackboard announcements. If you miss more than 3 classes, your grade will drop one letter grade (-10 points). Cell phones should be on silent during class. Laptops and tablets should only be used to take notes. And please, put the headphones and earbuds away.

ACADEMIC MISCONDUCT: Students at Texas A&M University-San Antonio are expected to adhere to the highest standards of academic honesty and integrity. Academic dishonesty for which a student is subject to penalty includes cheating, plagiarism, fabrication, multiple submissions, misrepresentation of academic records, facilitating academic dishonesty, unfair advantage, violating known safety requirements and ethical misconduct. #### **ASSIGNMENTS**

READING QUIZZES AND IN-CLASS ASSIGNMENTS: 30% There will be Blackboard quizzes over the assigned readings throughout the semester. There will also be class work that you will complete in small groups over the reading/lecture material. Each student is responsible for writing their own answers. There will be a Breakfast Quiz when attendance is low.

CHECK-IN JOURNALS: 10%. There will be 4 check-in journal posts due throughout the semester. The writing in this space is different from other assignments, as it doesn't necessarily have to be formal. Other students will not see what you write.

**EXAMS**: 30%. There will be 2 exams throughout the semester. These exams will have a combination of IDs, short answer, and/or essay questions.

FINAL EXAM: 30%. The final exam will take place during the last week of class. It will be cumulative, covering all our material for the semester. It may be a mixture of multiple choicetype questions, short answer questions, and one essay question.

### The Elephant in Our Classroom

TL;DR The use of AI is not allowed. It constitutes academic dishonesty. You will get a zero.

AI is everywhere these days, so let's confront the elephant in our classroom-the elephant in every classroom. Here's what happens every time you use AI: the software draws from the published work of others--without their consent, without citing them or compensating them-and produces a seemingly polished piece of writing. But this piece of writing is full of made up evidence and falsified citations. The skills required of a college student include reading critically; assessing a scholar's use of evidence; making connections between sources; understanding categories of analysis, like race, class and gender; and constructing your own arguments that require you to use all these skills. AI plagiarizes from people who have waded through these intellectual trenches. It does not itself have these skills. And every time you use AI to write or to construct analysis, you are losing the ability to do this yourself. Writing and critical thinking are not easy skills to develop. They can make you uncomfortable and uneasy. They are time consuming and inconvenient. But they help you develop your voice as a writer, as a thinker, and as a human being living in our modern world. With our backs against the wall, we're forced to answer the question: how much are we willing to pay for convenience? If you've read this far, you know that I believe the costs are too high. Students are not authorized to use any AI software in this course, and I will not use it either. It is dishonest and a form of plagiarism. You will not receive any credit for work that uses AI.

SIX-DROP RULE: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007.
