Catalog Description. : In-depth study and applications of polynomial, rational, radical, exponential and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability, and conics may be included. This course meets the standards for the Mathematics category of courses under the core curriculum.

Prerequisites. Evidence of math equivalent to High School Algebra II (“C” or higher) or placement; Requires passing TSIA Math score.

Required Material. Online access code for College Algebra by Robert F. Blitzer (8th edition) with MyMathLab, Pearson Publishing, ISBNXXXXXXX (E-book included with access code).

Attendance Policy. Attending class is mandatory. In all cases of absences and tardiness or leaving early, students will be held responsible for the completion of course requirements covered in their absence. Students are expected to attend class as scheduled and be prepared to participate in discussions and in-class exercises. If you miss class, you are responsible for finding out what you missed on that day. You are welcome to ask questions about the topics that you missed; however, it is your responsibility to learn the material. You are strongly encouraged to attend all classes. In addition, if an unavoidable situation prevents you from being on time or if you must leave early, please minimize class interruption. After 6 absences, you can be dropped for nonattendance by your instructor without further notice.

Calculator Policy. Only scientific calculators are permitted. Some topics may be covered with the assistance of a graphing calculator. Online math utilities (e.g., Desmos) are not allowed on exams. Note: Laptops, cell phones, and other mobile devices are NOT acceptable calculators. Note that you can borrow calculators from the library for the entirety of the semester or for a 2-hour period. Make sure you mention to the library that you want a calculator for the entire semester, otherwise they will assume you borrowed the calculator for only 2 hours and they might charge or place a hold on your account.

Homework. All homework assignments will be assigned weekly and completed through Pearson’s MyMathLab. You may access MyMathLab via Blackboard.

Quizzes. Quizzes will be completed on MyMathLab. All due dates are listed in MML. Quizzes may be attempted three times, and each quiz attempt has a time limit. Only the highest score will be counted. Students should attempt the quiz multiple times in order to be prepared for the exams.

Examination. There will be 3 exams and a comprehensive Final exam. All exams will be in person and administered in class. Unless under extreme circumstances, there will be **no make-up** for exams. Please make sure to coordinate with the instructor **at least 24 hours prior** to the scheduled date and time of the exam.

Late Work. Late homework submissions will not be accepted. The workload distribution would be in such a way that will allow sufficient time for completion of each assignment.

Class Policy. All electronics should be used for **CLASS PURPOSES** only. Student Learning Outcomes. MATH 1314 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key algebraic concepts and appropriate applications related to everyday experience. The goal is for students to learn to see not only how useful mathematics is and how it helps us look through different lenses, but also how beautiful mathematics can be. Upon completion of this course, students will:

1. Demonstrate understanding and knowledge of properties of functions, including domain and range, operations, compositions, and inverses.
2. . Recognize and apply polynomial, rational, radical, exponential, and logarithmic functions, and solve and explain related equations.
3. Interpret and apply graphing techniques.
4. Evaluate all roots of higher degree polynomial and rational functions.
5. Recognize, solve, apply and explain systems of linear equations using matrices.

Financial Aid and Verification of Attendance.
