Student Learner Outcomes: Upon completion of this course, each student will be able to:

1. Describe the nature of research and explain the scientific method.
2. Understand the various steps of the research process and the factors that must be considered when selecting a research question.
3. Read and comprehend related literature and generate a working problem in which he/she is particularly interested.
4. Understand the role of the hypotheses and hypothesis testing in the research process.
5. Develop a hypothesis for a research project and synthesize this information to prepare a short review of literature.
6. Identify ethical codes that serve to guide research in the US and understand the importance of the Institutional Review Board and the informed consent.
7. Complete a human subjects application and attain simulated approval through the A&M-SA IRB.
8. Test a hypothesis and obtain data, analyze and interpret results by carrying out a small research project in a *specific* exercise science-related topic.
9. Effectively communicate knowledge of a specific exercise science-related current topic in written form through the preparation and completion of a research project.
10. Effectively communicate knowledge of a specific exercise science-related topic in verbal form through the oral presentation of the current research on the topic.

Class Attendance:

A vital part of every student's education is regular attendance of class meetings. Any absences tend to lower the quality of a student's work in a course, and frequent or persistent absences may preclude a passing grade or cause a student to be dropped from one or more courses upon the request of a faculty member to the Provost and Vice President for Academic Affairs.

- Students are allowed three absences that will not affect their grade (exemption to this rule is presentation day.) Attendance day is Mandatory (See more below)
 - You will have **10 points** deducted from your presentation grade for each day you are not present for other presentations. **Five points** will be deducted from your presentation grade for each presentation you miss (you will not be allowed to enter the room once a presentation has started) or if you leave early during other students' presentations.
 - Sign-in sheet will be passed out for in-classroom days. Failure to sign in (even if in attendance will count towards one of the three missed absence.
 - If you go over your three missed absences it will be 3 points for each towards your Overall grade.

 1. This includes not participating in one or more assessments for that lab.
 - iii. If you completely miss a lab and have no documentation, 20 points will be deducted from the written assignment
 - d. Points will be deducted from any participation grade that may be required of class as a result of unexcused absences.
 - i. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. 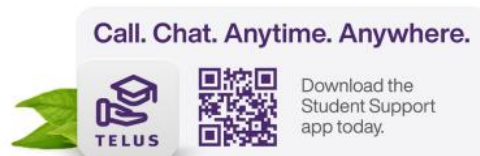

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. 3. A student has the responsibility to recognize that student actions reflect upon the individuals involved and upon the entire University community.
4. A student has the responsibility to recognize the University's obligation to provide a safe environment for learning.
5. A student has the responsibility to check their university email for any updates or official university notifications.

We expect that students will behave in a manner that is dignified, respectful, and courteous to all people, regardless of sex, ethnic/racial origin, religious background, sexual orientation, or

disability. Conduct that infringes on the rights of another individual will not be tolerated.

Students are expected to exhibit a high level of honesty and integrity in their pursuit of higher education. Students engaging in an act that violates the standards of academic integrity will find themselves facing academic and/or disciplinary sanctions. Academic misconduct is any act, or attempt, which gives an unfair advantage to the student. Additionally, any behavior specifically prohibited by a faculty member in the course syllabus or class discussion may be considered as academic misconduct.
