Catalog Course Description: Introduction to managerial accounting as it is used to plan, evaluate and control an organization. Emphasis on budgeting, standard costing and analysis of costs and profits.

Course Objectives: The objective of this course is to provide an understanding of business functions and provide sound financial management principles in a business setting.

Prerequisites: ECON 5301 and FINC 5302 or BUAD 5301 and BUAD 5302. Students who do not meet the pre-requisites must contact the instructor immediately.

Student Learning Outcomes:

After successful completion of the course, the student will be able to:

- (a) explain your knowledge of business functions such as accounting and financial management, supply chain management, customer relationship management, and human resource management.
- (b) explain what causes changes in costs and what are the patterns of change that are commonly observed.
- (c) use Cost-Volume-Profit analysis to predict future costs and profits at differing levels of business output.
- (d) use various costing methods to trace the costs of complex business operations.
- (e) use activity-based costing to make decisions to improve business actions
- (f) use accounting information to evaluate the efficacy of business segments, departments, and the performance of individual business managers

AACSB Assessment: The College of Business is in the process of applying for AACSB accreditation. As part of that process, students will be assessed on program level outcomes based on course outcomes from various courses. The materials from this course may be used for assessing such program level outcomes, and hence students must follow the necessary rigor to ensure mastery and retention of the above course outcomes.

Required Materials:

- **Textbook:** Managerial Accounting for Managers, 6th Edition by Noreen, Brewer, & Garrison. McGraw Hill. Students are required to read related chapters from the textbook before the class.
- **McGraw-Hill Connect:** Online assignments will be administered through Connect. PLEASE REGISTER IN CONNECT ASAP. To register in Connect, log into Blackboard and select Assignments tab. Click on any assignment which will take you to the integrated Connect platform.
- **Blackboard:** Connect to <http://tamusa.blackboard.com>. You will class materials in Blackboard. It may also be used for communication, assignments, quizzes and exams. Your user ID is the Jaguar ID (aka J Number e.g. J00001234). Password is the Date of Birth (MMDDYY). Students should monitor announcements in Blackboard several times a day. **Please do not use Blackboard message to contact me. Email me directly using your TAMUSA student email account.**
- **Computer Hardware:** In order to participate in online materials you will need a computer with an internet connection. To complete the class work, you will need appropriate software installed on the computer.
- **Time Expectation for coursework:** You are expected to spend 3-6 hours per week for the course. Based on the background, some student may require more time. Time spent may be longer when assignment/exams are due.

Examinations: There will be two mandatory mid-term exams and a mandatory final exam (as per university schedule). The exams/quizzes will consist of conceptual multiple-choice questions, and problem-solving questions. The exam/quiz materials will come from lecture notes, the text, and class discussions. Questions will emphasize understanding and applications of concepts and topics covered in class. **Missing an exam will result in a grade of zero for that exam and may result in a fail grade in the course.**

Assignments: Problem solving homework will be assigned for most of the chapters. The purpose of homework is to apply the information learned during class. Each problem-solving homework assignment will be available for two weeks to complete it. Students can refer to the homework schedule to find out exact dates for each assignment.

Make up and Late Assignment/exam/quiz policy: As a general rule, make-ups or late submissions will **NOT** be offered or accepted for any missed assignments/exams/quizzes. Late submissions or make-ups may be accepted/administered only in extraordinary circumstances such as an excused official university activity, a severe illness, or a dire emergency. However, you must provide comprehensive documentation either before or within a few days of the missed assignment/quiz/exam.

Course Requirements every student must fulfill in order to succeed in course:

1. Students should check the Course Calendar, Announcements, and Emails on a regular basis.
2. Students should keep current with all course assignments, quizzes, and examinations.
3. If the course uses remote proctoring for exams, students must schedule their exam early in the semester.
4. Students should ask questions and communicate with the instructor in-person/online.
5. For all classwork, exams, quizzes etc., if a student is completing it off-campus, then they are responsible for availability of internet connectivity. Extensions will not be granted for lack of availability of internet connections.
6. Students should remember that online and hybrid courses assume greater responsibility and independent learning skills by the student for their own learning outcomes.
7. For online courses, students should keep current on class recordings.
8. For online asynchronous courses, there will be no online class sessions. All materials will be made available through Blackboard or through online links.

Course Drop Policy: You may drop the course on or before **November 13, 2026**, with an automatic grade of W. If you wish to drop the class after that date, you will receive either a W (if you have satisfactory record so far) or F. The last date to drop a course or withdraw from the University is **November 30, 2026**. If you wish to drop the class, you must submit the necessary paperwork to the proper authority.

Class conduct and civility code: Everyone in class is expected to follow all rules in the student handbook, as well as common courtesy during classroom lectures and discussions online, including the following:

1. It is the students' responsibility to obtain and be able to use the required materials and software for this class.
2. For any questions about the exams and assignments, a student should contact the instructor **before the day they are due**, so the instructor may have enough time to provide feedback.
3. All communications will be via e-mail communications to the Texas A&M University e-mail account, and students are expected to use their school provided email account. It is the responsibility of the student to check their TAMUSA email regularly to receive updates on the logistics of the course. The instructor will reply to a student e-mail messages within 48 hours during weekdays (Monday-Friday).

Anyone violating these policies may be subject to disciplinary actions.

Class attendance and Participation: A vital part of every student's education is regular attendance of class meetings (for face-to-face/hybrid classes/online synchronous classes) or **regular review of class materials posted by the instructor for asynchronous classes**. Any absences tend to lower the quality of a student's work, and frequent or persistent absences may result in a failing grade. Students are responsible for the materials covered in class.

The course covers a lot of material, and most students find at least some parts of it difficult. The course is intensive and challenging, and you are expected to master the materials presented in class. The structure of the class makes your individual study and preparation outside of class extremely important. Reading the assigned chapter(s) and having some familiarity with them before class will be very useful for understanding lectures.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
