Catalog Description

This advanced course offers an in-depth exploration of the fundamental principles and current advancements in cell and molecular biology. Designed for students with a strong foundation in biological sciences, the course provides a comprehensive understanding of cellular structures, molecular mechanisms, and the intricate processes governing cellular functions. Students will examine key topics including cell structure and function, molecular genetics, gene expression and regulation, and protein synthesis. The course delves into advanced concepts such as cell signaling pathways, cell cycle regulation, apoptosis, and the molecular basis of disease. Emphasis is placed on integrating theoretical knowledge with practical applications, including an introduction to the latest research techniques and technologies.

Additional Description

This advanced graduate course examines how cellular metabolism and gene regulatory networks coordinate growth, development, and environmental responses. Emphasis is placed on understanding fundamental molecular mechanisms through guided discussions of landmark discoveries and contemporary research, primarily in plants while drawing parallels with yeast, mammalian, bacterial, and other model systems. Rather than relying on traditional lectures, the course uses instructor-led discussions, collaborative problem solving, invited experts, and critical evaluation of experimental evidence to explore how cells integrate metabolic, genetic, and environmental information

Learning Outcomes

- Integrate metabolism with gene regulation and cellular function.
- Critically evaluate experimental design and modern molecular techniques.
- Interpret genomics, transcriptomics, proteomics, and metabolomics data.
- Design experiments to test mechanistic hypotheses.
- Communicate scientific ideas through discussion and scientific writing.

Topics that will be covered (week wise)

Each topic will begin with a brief instructor-led discussion of key concepts, followed by a guided analysis of a review article that provides foundational knowledge for the subject. During the following week, students will lead and participate in discussions of a primary research article that builds on the previous week's topic. Students are expected to complete all assigned pre-readings prior to class to facilitate meaningful discussion and critical analysis. Assessment will be cumulative and based on weekly participation and performance in article

discussions, completion of assignments associated with guest lectures, and the development, written presentation, and oral defense of a research proposal.

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
