Time and Place of Class Meetings:

BIOL 5311 lectures will take place on Tuesdays from 5:30-8:15pm in the SciTech room 375.

Description of Course Content:

This course offers a comprehensive exploration of research methodologies employed in field biology, encompassing techniques in ecology, physiology, behavior, and evolution. Designed for advanced students, the course integrates theoretical knowledge with practical, hands-on experience to equip students with the skills necessary for conducting rigorous field research. Students will engage in a series of laboratory sessions and field exercises, each focused on different aspects of field biology research. The course begins with an introduction to field research methods and progresses through experimental design, habitat and vegetation sampling, wildlife tracking, physiological measurements, behavioral observations, and evolutionary studies.

Student Learning Outcomes:

1. **Design and implement field-based research projects.**
2. **Apply appropriate statistical analyses to ecological data.**
3. **Master essential field techniques.**
4. **Effectively communicate scientific findings.**
5. **Adhere to ethical and safety standards in the field.**

Career-Readiness:

1. **Practical Field Skills:** Students gain hands-on experience with techniques essential for careers in wildlife management, environmental consulting, and ecological research.
2. **Data Analysis and Interpretation:** The course teaches students to process and interpret complex biological data.
3. **Scientific Communication:** Students learn to effectively present their research findings through formal scientific writing and oral presentations.

This class uses the learning management system Blackboard Ultra to administer content and evaluate understanding. I will post links to videos, notes, reading materials, digital supplements, and administer essay exams from this learning platform.

Grading Policy:

I use the following standard scale when assigning your overall grade:

90-100%=A, 80-89%=B, 70-79%=C, 60-69%=D, 0-59%=F.

Grade Components:

Your grade will be determined by one Research Proposal (250 points), two Data Analysis Exercises (75 points each), eight team-based activities (25 points each), one Historical Figure Presentation (50 points), and participation in class discussions (50 points). Your grade will be determined by the number of points earned divided by the total points possible (700 points).

Research Proposal: There will be one research proposal exercise where you will draft a formal research proposal for a project incorporating field biology. This proposal should outline a clear, testable hypothesis about a biological question that can be investigated in a natural setting. You'll need to define your research question, explain its significance, and describe the specific methods you would use to collect and analyze data.

Data Analysis Exercises: There will be two exercises where you will be asked to analyze and interpret data.

Historical Figure Presentation: You will be assigned a historical figure/aspect in Field Biology and prepare a 5-minute presentation on their life and contribution to the field.

Team-Based Activities: After our initial lecture most days, you will be assigned to a 2-3 student group and given a topic to research and present. You will have one hour to work as a group to produce a 15-20 minute presentation on the topic. Google Slides will be the preferred method of presentation, but I am open to whatever your group decides. The 25 points will be allocated using a rubric that includes effectiveness of the presentation (10 points), content (10 points), and a confidential peer evaluation (5 points). Groups will be different every class period.

Participation: We will post papers for you to read in preparation for class. During class, I will note your contributions to our conversations on weekly topics. You do not have to comment every class period, but you should make multiple comments throughout the semester. We will also take a couple of trips to Espada to put some of the techniques we learn into practice.

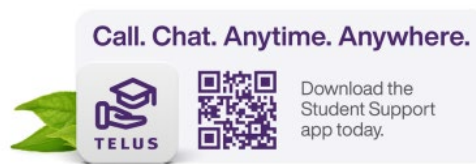

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
