Course Description

Credit: 1 (1-0-0)

Research Experience in Biology is aimed at providing an introductory research experience in a biology faculty laboratory. Through this experience the student will gain an understanding of how research is conducted outside of a classroom and how the scientific method is actively applied in the specific discipline of the faculty research interests. Students will become part of the research team and will participate in laboratory or field activities as well as meetings/discussions. This course can be repeated for a maximum of 2 credits, the second of which must be under a different faculty member and thus a different discipline in Biology. This course can also be taken as zero-credit during the summer to maintain enrollment for compliance. This course is recommended to be taken before BIOL 4304: Research Projects in Biology. TSI Restriction(s): Reading, Math, and Writing

Prerequisites: BIOL 1306, BIOL 1106, BIOL 1307, BIOL 1107.

Restrictions: Graduate level students may not enroll.

Repeat Status: Course may be repeated 1 time(s).

Course Materials

All materials and equipment necessary to conduct the assigned research will be provided in the laboratory. Students are expected to conduct literature searches, identify appropriate experimental methods, and develop research ideas related to the laboratory's current research interests. At the beginning of the course, students may seek guidance from the faculty research mentor in selecting a research topic and identifying suitable methods. As the course progresses, students are expected to become increasingly independent in planning and carrying out their research.

Learning Objectives

Upon successful completion of this course, students will be able to:

- Identify a research problem
- Conduct a literature search using appropriate scientific sources.
- Design an appropriate experiment to investigate a research question.
- Use appropriate laboratory equipment, instruments, software, and other research tools.

- Conduct laboratory research while following required safety procedures.
- Complete required training related to laboratory safety, research ethics, and responsible conduct of research.
- Collect, analyze, and interpret experimental data.
- Maintain accurate and complete records of research activities and results.
- Communicate research findings effectively in written, poster, and oral formats.

Evaluation

Students will be evaluated based on their research participation, documentation, completion of required training, literature review, and presentation of research findings.

Each component will be evaluated based on the student's participation, quality and completeness of work, fulfillment of assigned responsibilities, and progress throughout the semester.

to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

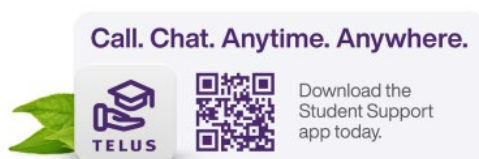

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.
