Research in Chemistry- CHEM 3304 Syllabus

This course places undergraduate students directly into an active research laboratory. Rather than following a fixed set of pre-scripted experiments, students join an ongoing research effort in the Hassan Lab and contribute to real, unresolved scientific questions in the areas of electrochemistry, materials chemistry, and separations science. Students work under the direct mentorship of the instructor and senior lab members, progressing from structured training toward increasingly independent experimental work over the course of the semester.

The course is designed to give students authentic experience of what it means to do chemistry as a practicing scientist: forming hypotheses, designing and troubleshooting experiments, interpreting ambiguous data, and communicating findings, all within a functioning research group.

Learning Objectives

By the end of this course, students will be able to:

- Apply the scientific method to an open-ended research problem, including formulating testable hypotheses and designing appropriate experiments.
- Safely and competently operate standard chemistry research instrumentation and laboratory equipment relevant to the lab's work.
- Maintain a rigorous, reproducible lab notebook and data record consistent with professional research standards.
- Locate, read, and critically evaluate primary scientific literature relevant to an ongoing project.
- Execute standard operating procedures accurately and troubleshoot unexpected experimental outcomes.
- Analyze and interpret quantitative experimental data, including basic statistical treatment and error analysis.
- Communicate scientific results clearly in both written and oral/poster form, appropriate to a scientific audience.
- Practice laboratory safety, chemical handling, and waste management in accordance with institutional and regulatory standards.
- Function as a contributing member of a collaborative research team, including giving and receiving constructive feedback.
- Reflect on research as a career pathway and articulate how laboratory experience connects to broader scientific and professional goals.

What Students Will Gain Hands-On Experience With

Laboratory & Instrumental Skills

- Preparation and handling of chemical solutions, reagents, and standards
- Electrochemical techniques (e.g., cell setup, electrode preparation and coating, controlled deposition/extraction experiments)
- Use of analytical instrumentation for elemental and compositional analysis (e.g., ICP-MS/OES, XRF)
- Materials characterization techniques (e.g., SEM/EDS, thermogravimetric analysis) as applicable to ongoing projects
- Proper use of personal protective equipment, fume hoods, and chemical safety protocols

Research Practice Skills

- Designing controlled experiments and identifying appropriate variables
- Recording and organizing data in a professional laboratory notebook
- Reading and synthesizing peer-reviewed literature to inform experimental design
- Basic data analysis, plotting, and interpretation of experimental results
- Presenting research findings through written summaries and oral or poster presentations
- Working within a research group: giving progress updates, receiving mentorship, and collaborating with peers

Course Structure & Weekly Progression

The semester is organized into phases that move students from structured onboarding toward independent contribution. Exact pacing may be adjusted based on individual student progress and the needs of the ongoing research project.

1–2	Onboarding & Safety	Lab safety certification, SOPs, chemical hygiene plan, waste handling, PPE, electrical/electrochemical safety, lab notebook standards
3–4	Literature Foundations	Guided primary-literature review; research question framing; introduction to relevant electrochemistry and separations concepts
5–6	Techniques Training	Hands-on training on core instrumentation and methods used in the lab (electrochemical cells, electrode preparation, analytical instrumentation)
7–10	Guided Experimentation	Supervised bench work on an assigned sub-task; data collection, troubleshooting, and iterative protocol refinement
11–13	Data Analysis & Independent Work	Data processing and interpretation; increasing independence in experimental design and execution
14	Synthesis	Compiling results; drafting figures/tables; peer data review

Weeks	Phase	Focus
15	Communication	Written research summary and oral/poster presentation to the lab group

Expectations & Lab Meetings

- Students are expected to commit a minimum of [X] hours per week to lab work, scheduled in coordination with the instructor.
- Weekly or biweekly one-on-one or group check-ins with the instructor to review progress, troubleshoot, and plan next steps.
- Attendance at lab group meetings, where students may be asked to briefly present progress.
- Completion of required institutional safety training prior to beginning bench work.
- Adherence to all lab-specific safety rules, chemical hygiene procedures, and data management practices.

Assessment

Grades are based on process and professional development as a researcher, not solely on experimental outcomes. Research is inherently uncertain, and negative or inconclusive results are treated as valuable data when properly documented and analyzed.

Deliverables

- A complete, well-organized lab notebook (physical or electronic) maintained throughout the semester
- A short literature summary relevant to the student's assigned research task
- A final written research summary (approx. 3-5 pages) describing methods, results, and conclusions
- A final oral or poster presentation delivered to the lab group or department

Students must follow all chemical hygiene, waste disposal, and PPE requirements at all times. Failure to comply with safety protocols may result in removal from lab activities.

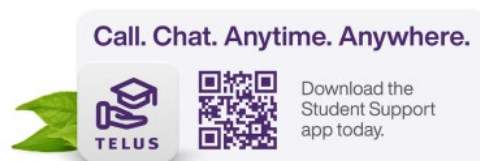

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
