As a co-requisite to CHEM 1311. Students attend a weekly recitation session. In weekly recitation sessions, you will meet with your instructor who will review course material, provide additional practice exercises, and/or answer questions on the material covered in regular classes and homework assignments.

Corequisites: CHEM 1311. TSI Restriction(s): Reading, Math, and Writing

Restrictions: Graduate level students may not enroll.

Course Materials

Textbook: "Chemistry: A Molecular Approach" 6th Edition, Author: Nivaldo J. Tro, Published by Pearson.

e-text subscription (with Mastering Chemistry) is included with the CHEM 1311 course. Follow the instructions sent by the bookstore. If there are any issues obtaining your access code, you can get 2-week temporary access while you work with the bookstore to resolve the issue.

Calculators: Scientific calculators are required for this course. Examples of acceptable calculators include TI30Xa and TI36X.

Learning Objectives

By the end of this course, students should be able to:

- Apply concepts learned in General Chemistry I lecture to solve conceptual and quantitative problems.
- Explain the reasoning and steps used to arrive at a solution.

Evaluation

This recitation course does not have a separate course grade. However, 50 points of the General Chemistry I course grade are based on recitation attendance.

To receive the full 50 points, students must attend all scheduled recitation classes. Five points will be deducted for each absence. Students are expected to attend regularly and participate in the problem-solving activities during each recitation session.

Communication: The best way to contact instructors is via email. All correspondence between professors and students must occur via Texas A&M University San Antonio email accounts. Students are expected to access Blackboard regularly for updates on the course, announcements, and other course materials. All students are strongly encouraged to come to office hours or make appointments at other times to discuss course material and ask questions.

Attendance Policy: All students are expected to attend all recitations and actively engage in class discussions, activities, and assignments. If you are absent, you are responsible for the material covered and are expected to get notes, announcements, and any other material from another student in the class. Absences are excused if due to illness (medical excuse), death of an immediate family member, religious holiday (please inform instructor), official University activity, cancellation of classes, military duties, pregnancy & related conditions, or participation in legal proceedings. Excessive unexcused absences (more than 3) and tardiness may be penalized.

AI policy: No Use of Generative AI Permitted

CHEM 1011 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Conduct and Behavior: As an instructor, my goal is to create a safe and engaging learning environment. Class disruptions are unacceptable, asking questions to clarify material during class does not qualify as a disruption and is encouraged. If you disrupt the class, you will be asked to leave for the day. Technology in the classroom may be a great resource, but it can also hinder the learning process. Therefore, students are not allowed to wear ear buds and headphones and/or use cellphones during class. All cellphones must be on vibrate or turned off for the entirety of the class/lab period. In case of an emergency call, leave the room before answering the call. Texting/Tweeting/etc. during class is absolutely prohibited. The use of laptops, tablets, or other devices for non-class related activities is not allowed.

Aggressive Behavior: The academic environment is meant for discussing ideas in a respectful manner. Tolerance, empathy, respect, and courtesy help us create a safe environment. Abusive and aggressive behavior will result in contacting the University Police Department and immediate removal of the student from the classroom.

Visitors: Only students enrolled in the course are allowed in the classroom. No visitors are allowed.

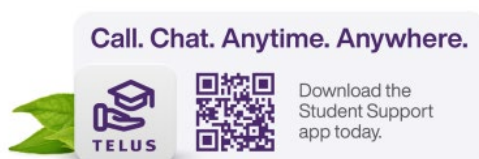

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC): The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights
