Course Description

The first half of the organic chemistry sequence intended for science majors. A study of the structures, syntheses and reactions of organic compounds. Prerequisites: A grade of C or better in CHEM 1312. Corequisite: CHEM 2123, CHEM2023.

Course Materials

Textbook: Organic Chemistry: A Learner Centered Approach by Richard Mullins (1st ed).

Homework: Homework will be assigned online from Pearson's MyLab and Mastering Chemistry.

Setting up Pearson's MyLab and Mastering: This involves two steps:

Step 1: Gettig access code: Since Follett has transitioned away from using Brytewave, access code is provided through Kortext. There are 2 different ways you can gain access:

I) A Kortext account will be created using your TAMUSA email address. You may have already got an email in your TAMUSA email letting you know the code has been added to your Kortext shelf. Please double check your email. Click the emailed link and it will take you to your Kortext account where you can log in using your TAMUSA email address and find your preloaded material on your Shelf.

II) You may alternatively go directly to Kortext to monitor and access your material:

- Navigate to <https://app.kortext.com/login>
- Enter your TAMUSA email address and click "Next"
- Select "Forgot Password" (for first time login)
- Use your TAMUSA email address to reset your password
- Once you gain access to your Shelf, click on the courseware on your bookshelf, in the section that says, 'Reveal your access code' you will see a purple button saying 'Reveal' or 'Copy'
- Click this button to reveal your access code

Step 2: Registration for MyLab and Mastering Chemistry: You must register through your blackboard course home page (NOT directly from Pearson's website!). Login to your blackboard and go to your course home page. Click "MyLab and Mastering Course Home" link located in "Course content". Follow the instructions thereafter and use access code you got from "step 1 above". Once you complete your registration, you will have access to your online homework as well as e-book.

Learning Objectives: By the end of this course students will be able to:

- Bonding and its consequences on molecular structure and reactivity
- Interplay between electronic, steric, and orbital interactions in the behavior and properties of molecules
- The dependence of structure and reactivity on context, particularly solvent effects and other non-covalent interactions
- Lewis and Brønsted acid-base chemistry
- Stereochemistry and conformational analysis
- Addition, elimination, substitution and rearrangement mechanisms
- Functional groups and their interconversions
- Organic synthesis
- Methods of activation, including Brønsted or Lewis acid/base, free radical chemistry
- The understanding that our only way to molecular knowledge is through spectroscopy and computational simulations

Attendance Policy: All students are expected to attend all classes and be fully and actively engaged. Attendance will be monitored. Absences will be excused if due to illness (medical excuse), death of a close family member, religious holiday (please inform instructor), official university activity, cancellation of classes/closure of the University, military duties, pregnancy & related conditions, or participation in legal proceedings.

Late Work Policy: Work is required to be turned in on time. Late work will not be accepted.

Visitors: Only students enrolled in the course are allowed in the classroom. No visitors are allowed.

Conduct and Behavior: My goal is to create a safe and engaging learning environment. Class disruptions are unacceptable, asking questions to clarify material during class does not qualify as a disruption and is encouraged. If you disrupt the class, you will be asked to leave for the day. Technology in the classroom may be a great a resource, but it can also hinder the learning process. Therefore, students are not allowed to wear ear buds and headphones and/or use cellphones during class. All cellphones must be on vibration mode or turned off for the entirety of the class/lab period. In case of an emergency call, leave the room before answering the call. Texting during class is absolutely prohibited. The use of laptops, tablets or other devices for non-class related activities is not allowed.

Electronic Devices During Exams: All electronic devices must be completely stored during exams and quizzes. Academic misconduct and attempts to cheat during the exam will be pursued according to Texas A&M-San Antonio code of conduct policy. You are discouraged from leaving the room during an exam. If you need to use the restroom, ask and leave all electronic devices with the instructor.

in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Exams: Exams will be done during the class hour. There will be **no makeup examinations for unexcused absences!** Should you miss two or more exams via an unexcused absence a grade of F will be assigned. Should you have a question concerning the way that your examination was graded, or if you think that there was an error in calculation the exam score, then it is your responsibility to bring the matter to the attention of the instructor within three calendar days of the date when your exam was given. The three-day policy applies to all 100-point exams, except the last 100-point examination. Students have until the day of their final examination to bring up grading concerns. No extra examination time will be given, the only time that the students have to work on the examination is the allotted time.
