Course Description

Credits: 3 (3-0-0)

Theory and application of gravimetric methods; acid-base, precipitation, and complexometric volumetric titrations; analytical separations, spectrophotometric and electroanalytical techniques; statistical and computer tools.

Prerequisites: A grade of C or better in [CHEM 1312/1112](#) and [MATH 1314](#).

Corequisites: [CHEM 3131](#). TSI Restriction(s): Reading, Math, and Writing

Restrictions: Graduate level students may not enroll.

Course Materials

Textbook: Quantitative Chemical Analysis, 11th edition, Daniel Harris and Charles Lucy (Published by Macmillan Learning). A personal laptop with the latest version of Excel is highly recommended. Online access to the Achieve platform is necessary to complete homework and other assignments.

Homework: Homework will be assigned from end-of-the-chapter problems in the textbook and/or from online homework associated with your textbook.

Calculators: Scientific calculators are required for this course. Examples of acceptable calculators include TI30Xa and TI36X. Programming mode is not allowed on exams.

Writing Resources: Students are expected to use course materials and class notes to complete writing assignments. [The Writing, Language, and Digital Composing Center at Texas A&M University-San Antonio](#) is available to support students with drafting, revising, and improving their writing. Students are encouraged to seek assistance as needed.

Learning Objectives

By the end of this course students will be able to:

1. Statistically analyze data.

2. Determine sources of error and how to account for these errors.
3. Use calibration curves for quantitation.
4. Apply principles of equilibrium to quantitative chemical analysis.
5. Understand different types of titrations and their use in quantitative analysis.
6. Clearly explain and communicate quantitative chemical concepts, data analysis, and results in written form

Writing-Intensive (WI) Designation

This course is designated as a Writing-Intensive (WI) course. Students will engage in regular writing assignments designed to improve their ability to explain quantitative chemical concepts, interpret data, and communicate scientific reasoning clearly. Writing will occur through weekly assignments, a major writing assignment, peer review, and revision.

Weekly Writing Assignments:

Students will complete approximately 10 short writing assignments (~200 words each). For each assignment, students will identify 3-4 key concepts learned during the week and explain them in their own words. Copying from textbooks, notes, or online sources is not allowed.

Major Writing Assignment:

Students will complete an article review (minimum 800 words) based on a peer-reviewed journal article. The assignment includes Draft 1, peer review, and a final revised submission incorporating feedback.

Peer Review:

Students will review a classmate's draft using a structured rubric and provide specific feedback on concept explanation, data interpretation, error analysis, and clarity.

Reflection Assignment:

Students will complete a 300–400 word reflection evaluating their development in writing and understanding of course concepts.

Important note:

For weekly writing assignments, the use of AI tools is not allowed. For the major writing assignment, AI may be used only for grammar or sentence clarity, not for generating content. Please refer to the **AI Policy** section of this syllabus for additional details regarding acceptable and unacceptable use.

Evaluation

Student performance in this course will be assessed using a combination of exams, homework, writing assignments, and a major writing project.

Exams – 200 points

- Best 2 of 3 hourly exams: 100 points
- Final exam: 100 points

Homework – 180 points

- 6 assignments × 30 points each
- Focus on problem-solving and quantitative calculations

Weekly Writing Assignments – 200 points

- 10 assignments × 20 points each

- Each assignment (~200 words) requires students to identify 2–3 key concepts learned during the week and explain them in their own words
- Responses will be graded based on completion, accuracy, and clarity of explanation

Major Writing Assignment – 175 points

Students will complete a formal article review (minimum 800 words) based on a peer-reviewed journal article.

- Draft 1: 25 points
- Peer Review: 25 points
- Final Draft (revised): 125 points

The final draft must incorporate peer and instructor feedback and demonstrate clear improvement.

Reflection Assignment – 50 points

- A 300 to 400-word reflection evaluating students' development in writing and understanding of course concepts

Total Points: 775

To calculate your grade, use the following equation: $\frac{\text{Points earned}}{\text{Total points}} \times 100$

All homework/exam grades will be posted to Blackboard. However, Blackboard course percentages are **not** considered as official, and students should use caution when using those to evaluate overall course grades. To calculate your grade, use the equation above. Letter grades are determined as follows:

Communication: The best way to contact instructors is via email. All correspondence between professors and students must occur via Texas A&M University San Antonio email accounts. Students are expected to access Blackboard regularly for updates on the course, announcements, and other course materials. All students are strongly encouraged to come to office hours or make appointments at other times to discuss course material and ask questions.

Attendance Policy: All students are expected to attend all lectures and actively engage in class discussions, activities, and assignments. Attendance may be monitored. If you are absent, you are responsible for the material covered and are expected to get notes, announcements, and any other material from another student in the class. Late Work Policy: Homework due dates are listed on the syllabus for physical turn into the instructor. 20% will be deducted for late submission every day up to 3 days after the due date. No work will be accepted 3 days after the due date.

AI policy: No Use of Generative AI Permitted

CHEM 3331 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Conduct and Behavior: As an instructor, my goal is to create a safe and engaging learning environment. Class disruptions are unacceptable, asking questions to clarify material during class does not qualify as a disruption and is encouraged. If you disrupt the class, you will be asked to leave for the day. Technology in the classroom may be a great resource, but it can also hinder the learning process. Therefore, students are not allowed to wear ear buds and headphones and/or use cellphones during class. All cellphones must be on vibrate or turned off for the entirety of the class/lab period. In case of an emergency call, leave the room before answering the call. Texting/Tweeting/etc. during class is absolutely prohibited. The use of laptops, tablets, or other devices for non-class related activities is not allowed.

Electronic Devices during Exams: All electronic devices must be completely stored during exams and quizzes; this does not include approved scientific calculators (see course materials). Academic misconduct and attempts to cheat during the exam will be pursued according to Texas A&M-San Antonio code of conduct policy. You are discouraged from leaving the room during an exam. If you need to use the restroom, ask and leave all electronic devices with the instructor.

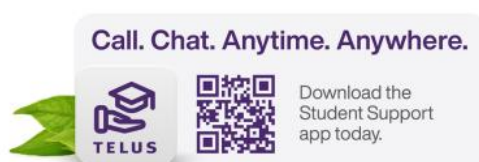
