Textbook/Materials

None, but you will also need a smartphone and a set of headphones – preferably over-the-ear. The lab is equipped with headphones and desktop Macintosh computers for your use, or you may use your own laptop. The university provides free access to the Adobe Creative Suite, for most assignments. Please sign up for access via Blackboard/Google Drive.

Course Description

Students in this course obtain practical skills and acquire working knowledge of the content-producing methods and formats in use by mass media. Using a relevant software foundation that includes smartphone applications, students create content as well as analyze and critique professional media, based on an understanding of the function, roles and legal/ethical responsibilities of mass media in society.

Media Literacy

By the end of this course, students will be able to:

- Critically analyze media messages: Students will learn to identify the creators, purpose, and target audience of various media messages. They'll recognize how media influences beliefs and behaviors and understand the economic and political factors that shape media production and distribution.
- Evaluate information credibility: Students will differentiate between credible and non-credible sources and recognize misinformation, disinformation, and propaganda. They'll also understand the role of algorithms and social media in shaping information consumption.

Audio Storytelling

Upon completion of this section, students will be able to:

- Comprehend audio production basics: Students will understand the fundamentals of audio recording, including microphone types, recording techniques, and editing software. They'll be able to identify and use basic audio production equipment.

- Produce narrative audio: Students will be able to script, record, and edit a short audio story or podcast. They'll demonstrate an understanding of sound design, including the use of music, sound effects, and voice-over to create a compelling narrative.
- Analyze audio genres: Students will be able to identify and critique different genres of audio storytelling, such as podcasts, radio documentaries, and audio dramas.

Photo Storytelling

By the end of this section, students will be able to:

- Master photographic composition: Students will understand and apply principles of photographic composition, such as the rule of thirds, leading lines, and framing. They'll also be able to use light and shadow effectively.
- Use photography as a narrative tool: Students will learn how to use a series of photographs to tell a cohesive story. They'll develop a photographer's eye, capturing moments that evoke emotion and convey meaning.
- Edit and manage digital photos: Students will be proficient in using photo editing software to enhance and manipulate images responsibly. They will also learn how to properly organize and archive digital photo files.

Video Storytelling

Upon completion of this course, students will be able to:

- Grasp video production fundamentals: Students will understand the basic stages of video production: pre-production (scripting, storyboarding), production (shooting), and post-production (editing).
- Create short-form video content: Students will be able to conceptualize, shoot, and edit a short video, such as a documentary or a promotional video. They will understand how to use visual elements, sound, and editing to create a compelling narrative.

ASSESSMENT

Assignments will be graded on a rubric, provided before the assignment is due, so students understand the grading parameters. Assignments will be played back/viewed/listened to in class for a group critique and so students learn ways to improve their work or what techniques could make an assignment better. Grades are an accumulation of points, which will be averaged at midterm and end of term.

ASSIGNMENTS:

Media Comparison: Choose one story and go to two very different news sources (on the Media Literacy chart). Take note of which aspects of the story the outlet focuses on: is it slanted in one direction or another? Does it present all of the facts? How did it make you feel about the topic, based on each outlet's presentation of the facts? You will present your findings to the class. Up to 50 points.

Sonic ID: Interview a person and use 30 seconds of it along with your intro. Up to 50 pts.

Mini-podcast: This is an introductory assignment where you will interview and record two people about a topic. You will record an intro, transitions and an outro and edit the piece to 1 minute to 1:30. 50 points possible

Audio Feature: You will record and interview at least two people (one must be an expert) and gather nat sound to help set the scene. Sounds MUST be naturally occurring and not like sound effects or faked. This is different from the podcast in that this is a story, which uses the sound and interviews, as well as your intro and transitions to move it along. 100 points possible

Shapes in Nature: Pick 5 shapes and find them in nature. 50 points possible.

Cutlines-Write useful, meaningful captions for photos, beyond the obvious.50 pts.

Mini Photo Essay: You will submit 5-7 photos that tell a story. Each photo must show a different aspect of that story, and be shot from a different perspective (close-up, medium, wide). Cutlines will enhance the story behind the photo. 100 points

Video sequence: You will record a scene or a process with a beginning, middle and end. You will use FIVE shots and you will edit the piece to 30 seconds. 50 points possible.

Public Service Announcement: You will storyboard, write, shoot and edit a 30-second public service announcement for a real cause. 50 points

Advertisement: You will storyboard, write, shoot and edit a 30-second or 1-minute advertisement. 50 points

Optional final assignment (in lieu of the PSA and Advertisement: You will create an airline safety video (up to 60 seconds). Further explanation and examples will be done in class. (200 points possible.)

****New for Fall 2026: Vertical Video will be incorporated in your final assignment.

Deadlines will be announced in class and on Blackboard calendar.

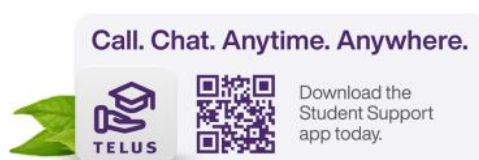

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility

criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The Jaguar Writing Center provides writing support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as eportfolios, class presentations, or other digital multimedia projects. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. Students' Rights and Responsibilities
