A. MAJOR COURSE DESCRIPTION/REQUIREMENT

In the last several decades, researchers have studied delinquency and theoretical developments in delinquency. Many studies have been conducted and have been analyzed resulting in various statistical data that is useful in exploring how delinquent behavior affects our society. This course is designed to present explanations for delinquent behavior and to introduce the learner to various causes, factors and theories, which include the relationship between delinquency and gender, problems in the family (neglect and abuse), school experiences, peers and gangs and drug abuse. Additionally, the learner will have a better knowledge and understanding of the issue of preventing delinquency and programs aimed at preventing delinquency as well as an overview of the juvenile justice process, relations with juveniles and police, juveniles and the court and juvenile corrections.

1. Understand the concept of delinquency.
2. Learn about theories of delinquency.
3. Familiarity with social, community, and environmental influences on delinquency.
4. Understand the juvenile justice system.

These should be well-thought out in advance.

Your final grade is an indication of the amount of information you have learned in this course, as well as the amount of dedication you have placed. There are no make-ups in this course in any assignment. Every assignment has a due date. Failure to observe a given due date for any assignment means a zero ("0") grade for that assignment once the due date has passed.

You will be given feedback during the course (extensive during the first 2 weeks). This feedback is intended to enable you to improve your answers on future tests and in your written work. 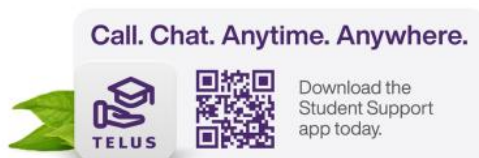

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
