A. Description

Historically, the work of criminologists has focused on the behavior of criminals and the subsequent response of the justice system. Unfortunately, this criminal justice paradigm continues to relegate victims to peripheral or secondary status. This course is designed to explain the victimology movement, which in recent years has made significant strides. The scientific study of victims includes the following major themes: the cost of victimization, restitution/restorative justice, sexual assault, intimate partner abuse, child maltreatment, elder abuse, homicide, victimization at work/school, and victim rights.

B. Objectives

1. Understand theories of victimization and measurement of crime and victimization.
2. Learn of victim rights and services.
3. Familiarity with justice systems.
4. Understand various violent and non-violent victimization.

You are also expected to integrate material from the textbook and outside sources into your written work wherever relevant. Misspelled words and grammatical errors should be corrected before submitting your work. Also, you should demonstrate the ability to think clearly about the answers you post. These should be well-thought out in advance.

Your final grade is an indication of the amount of information you have learned in this course, as well as the amount of dedication you have placed. There are no make-ups in this course in any assignment. Every assignment has a due date. Failure to observe a given due date for any assignment means a zero ("0") grade for that assignment once the due date has passed.

You will be given feedback during the course (extensive during the first 2 weeks). This feedback is intended to enable you to improve your answers on future tests and in your written work. 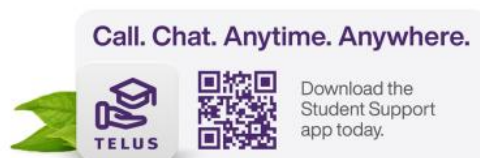

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
