Course Description

This course is an analysis of correctional processes and facilities available at the community level. Topics include: probation, parole, diversion, halfway houses, community reintegration procedures, community treatment centers and volunteer programs. Emphasis is placed on social structure, functions and problems of community-based programs. Prerequisites: CRIM 3321 and SOCI 1301. (Obtained from undergraduate course catalog)

Student Learning Outcomes

1. To identify and comprehend factors that relate to community-based corrections; probation, parole, diversion programs and evidence based practices.
2. To develop knowledge through assigned course literature and class lectures.
3. To develop critical thinking skills as they relate to community based corrections.
4. To develop knowledge on evidence based practices utilized in community corrections.
5. To apply knowledge and critical thinking skills in online discussions and assignments using Blackboard.

D. Grading

Assessment

There will be two exams. Each will consist of multiple-choice and T/F questions. The highest grade you can receive on each exam is one hundred (100). Dates and times are listed in the schedule on this syllabus.

There will be weekly quizzes during the semester. They open on Mondays at 8am and close on Sundays at 1159pm.

There will also be weekly discussions, which will be posted on Blackboard. The highest grade you can receive on each discussion is one hundred (100). You must answer the discussion completely every Thursday and respond to at least two other posts by Sunday. "Good job" is not a response. A good response is one that includes research which supports your responses and includes your thoughts. Do not expect full points for minimum effort. They open on Mondays at 8am and close on Sundays at 1159pm.

Assessing your performance in this class is based on several factors. One is how well you write your answers. Clear, concise answers are expected. You are also expected to integrate material from the textbook and outside sources into your written work wherever relevant. Misspelled words and grammatical errors should be corrected before submitting your work. Also, you should demonstrate the ability to think clearly about the answers you post. These should be well-thought out in advance.

Your final grade is an indication of the amount of information you have learned in this course, as well as the amount of dedication you have placed. There are no make-ups in this course in any assignment. Every assignment has a due date. Failure to observe a given due date for any assignment means a zero ("0") grade for that assignment once the due date has passed.

You will be given feedback during the course (extensive during the first 2 weeks). This feedback is intended to enable you to improve your answers on future tests and in your written work. Please take these comments and suggestions seriously because your learning is essential to your progress in the course as well as in the university. This course is not just about learning new material. You are interacting with other students as well throughout the course, primarily through the discussion board and the on-line forum. 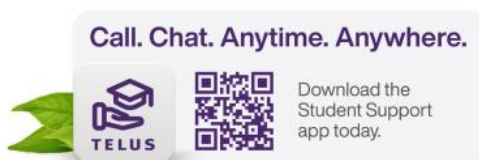

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. A non-punitive drop does not affect the student’s GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as “F” grades and will impact the student’s GPA.
