About the Course

Course Description

This course is an introduction to drawing. Through the development of critical thinking and technical skills, students will learn how to visualize, create, and evaluate drawn images. Techniques covered will include all basic aspects of drafting and depictions of space in 2D. Besides studio assignments and group critiques there also will be slide lectures and technical demonstrations.

Section Description

This is a studio art class for the general student and assumes no prior experience in drawing. Through the development of critical thinking and technical skills students will learn how to visualize, create, and evaluate drawn images.

Techniques covered will include media mastery, composition, observation of value, measuring, perspective, and rendering. In addition to studio practices such as technical demonstrations, studio assignments, group critiques, and collaborative assignments we will also engage with art theory through readings, presentations, and discussions.

- Portfolio Submissions: Students will submit a Midterm and Final Portfolio for grading to track their growth throughout the semester.

Learning Outcomes

Upon successful completion of this course, students will:

1. Demonstrate the use of fundamental principles and skills of drawing.
2. Apply a basic creative process to the development of visual images and ideas.
3. Analyze artwork using the fundamental vocabulary of the elements, and principles of art.

Core Competencies

1. Critical Thinking: Students will engage in creative and/or innovative thinking, inquiring analysis, evaluation, synthesis of information, organizing concepts, and constructing solutions.
2. Communication Skills: Students will demonstrate effective development, interpretation, and expression of ideas through written, oral, and visual communication.
3. Teamwork: Students will demonstrate the ability to work effectively with others to support a shared purpose or goal and consider different points of view.
4. Social Responsibility: Students will demonstrate intercultural competency and civic knowledge by engaging effectively in local, regional, national, and global communities.

Course Expectations

Studio Behavior

This course is a studio art course, which means that students will spend a large amount of time working in the art studio. All students participating in arts courses are expected to help maintain the space.

This may include:

- cleaning the space
- rearranging the room
- picking up after oneself
- do not permanently alter or damage the classroom or its tools

Failure to treat the studio respectfully will result in disciplinary action.

Attendance Policy

- You will be able to accrue 4 absences without penalty in this class. These absences will not alter due dates, and reading quizzes cannot be made up.
- The 5th absence will lower your course grade one full letter grade. Each additional absence will also lower your course grade by one full letter grade.
- Students who accumulate 7 absences will automatically fail the course and are encouraged to drop the class. Students that acquire 7 absences are no longer eligible to complete extra credit assignments. Extra credit cannot counteract a failure for reaching 7 absences.

- Be aware that you are only permitted a total of 6 drops without penalty in your undergraduate career. The 7th drop will be calculated as an F in your GPA. Be cautious about casually dropping classes.
- Arriving late or leaving class early may be considered an absence.
- Arriving to class unprepared may be considered as absent.
- Working on other class materials or not actively participating may be considered an absence.
- Attendance is calculated for each day of class meetings.
- You must sign in before the start of class to receive credit for your attendance.

Late Work Policy

Late work is not accepted in this class unless the student has contacted the instructor to receive an extension prior to the assignment's submission deadline. A one-class extension will be granted pending instructor approval. Late work will not be accepted beyond the one-class extension. **You will only be granted an extension if you contact me via email with your request before the assignment's due date.**

Grading

In-Class Exercises/Homework

Students will complete a series of short in-class exercises as we learn about and experiment with new media and techniques. These short homework assignments will count for 30% of your overall course average.

Projects

Students will execute several "long" drawings over the course of the semester. These will be worked on in and out of the classroom and will count as major grades for the course. These projects will count for 60% of your overall course average.

Portfolios

Students will turn in two work portfolios to document growth over the semester. These portfolios are worth 10% of your grade.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. The Six-Drop Rule

A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.
