Course Description: This course provides an in-depth exploration of exercise testing and prescription principles for diverse populations, including apparently healthy individuals, those with chronic diseases, and special populations. Students will learn to assess fitness components such as cardiorespiratory endurance, muscular strength, flexibility, and body composition. Emphasis is placed on interpreting fitness assessment results to develop safe and effective exercise prescriptions tailored to individual needs and goals, in alignment with evidence-based guidelines.

Course Objective: Upon completion of this course, each student will be able to:

1. Demonstrate proficiency in conducting and interpreting health-related fitness assessments.
2. Apply physiological principles and current guidelines to design individualized exercise prescriptions.
3. Identify contraindications and safety considerations for exercise testing and prescription.
4. Develop evidence-based exercise programs for various populations, including those with chronic conditions.
5. Communicate fitness assessment results and exercise recommendations effectively to diverse audiences. Test a hypothesis and obtain data, analyze, and interpret results by carrying out a small research project in a specific exercise science-related topic.

Assignments: All assignments (e.g., lab report, presentation, mid & final exams, etc.) are due at set specific times throughout the semester. Details of each assignment will be provided in class.

Of note, late assignments will not be accepted (i.e., 0 point).

Extra Points: If you participate in research (and submit the evidence of participation) from the Kinesiology program, extra points will be added to your final points for the grade.

Academic Dishonesty: Students are expected to do their own course work. Academic dishonesty (e.g., cheating, plagiarism, fabrication, lying, bribery, threat, etc.) is a violation of the Student Code of Conduct; therefore, the instructor will report any form of academic dishonesty to the Office of Student Rights and Responsibilities.

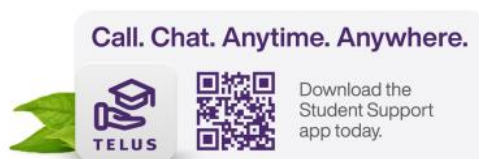

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
