COURSE DESCRIPTION:

In addition to introducing Shakespeare's major genres, this course invites students to consider Shakespeare's cultural status, to ask how social difference informs his works, and to study adaptations and appropriations of Shakespeare in diverse contexts.

ADDITIONAL INFORMATION:

Drawing on American legal scholar Kimberlé Crenshaw's concept of "intersectionality," that is the intersection of identities that work in tandem to create unique experiences of advantage and disadvantage, this course will examine how Shakespeare's plays incorporate, communicate, and complicate representations of class, gender, race, and other social identities in relation to power, be that power in governance, relationships, or warfare. We will examine Shakespeare's plays both in relation to the historical moments they were constructed in, and how his work has been more recently adapted to showcase how they can remain relevant and illuminating commentaries on society.

WRITING INTENTIONAL (WI):

This course is Writing Intentional (WI). This means we will focus on the writing and revision process and take time to work and collaborate on assignments in class. Throughout the course, you will employ writing to better understand Shakespeare's plays and their continued impact on societies. To that end, you will complete multiple writing assignments, both low and high stakes and in various genres, and you will have ample opportunities for revision in response to peer and instructor feedback.

REQUIRED TEXTS:

Any version of the following plays that uses Shakespeare's original language:

Othello
Henry V
Richard III
Twelfth Night

The Norton Shakespeare or Folger's edition (which can be found for free here: <https://www.folger.edu/explore/shakespeares-works/>) are excellent choices. You may use other

versions (ex. No Fear Shakespeare, summaries) to help you understand the text, but you may not use these as substitutions.

All other readings will be available through Blackboard.

COURSE LEARNING OUTCOMES:

- **Gain familiarity with Shakespeare’s major genres, historical context, and cultural impact.**
- **Develop oral and written communication skills, including rigorous analysis, close reading, and academic, thesis-driven argumentation.**
- **Establish the ability to analyze and articulate the significance of adaptations of Shakespeare’s works, particularly as commentary on intersectional issues.**
- **Learn to collaborate with a group of peers, developing teamwork skills in an academic setting.**
- **Practice creative planning and problem solving through the process of drafting, writing, and presenting.**

AI POLICY:

No Use of Generative AI Permitted

ENGL 3331 assumes that all work submitted by students will be generated by the students themselves, working individually or in groups. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Use of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

NOTE: You may use spell and grammar-check functions such as those available from Grammarly. However, any generated content (such as significant changes suggested by Grammarly Pro) is not permitted. One of the goals of this course is to develop critical and creative thinking, and using AI-generated content takes away from that process.

Paper Submissions:

All papers must be submitted online through Blackboard.

Formal essays (not necessarily journals) should be formatted as such:

- 12-point font, Times New Roman typeface.
- One-inch margins and double-spaced (no spaces between paragraphs).
- MLA style citations, with your name, my name, the class, and date on the upper left corner. **Please include a title.**
- Include the word count at the end of the paper.

Journals: Throughout the semester, you will submit journal entries about a topic related to our readings for the week that they are due. These are low-stakes assignments, meant to help you generate ideas and think about the texts, giving you the opportunity to explore ideas that may help you understand the readings in a new way. You may also think of these as a way to brainstorm ideas for your major writing assignments.

Class Participation and Attendance

Because our class is participation-based, attendance is mandatory and will make up a portion of your participation grade. Since missing class is sometimes unavoidable, you will have **four** excused absences available to you this semester. Each absence beyond four may lower your final grade by one letter. Please contact me as soon as possible to discuss possible alternatives for extreme cases if you are required to miss more than the allotted amount. In class quizzes and assignments may not be made up.

Technology

You are expected to bring something to write with during class. Laptops or pen and paper are permissible, but please refrain from using a computer for anything unrelated to class. Excessive misuse of technology will result in an absence. Cell phone usage is prohibited, unless you have extenuating circumstances, which I will happily approve.

Late Work

I am happy to grant extensions as long as they are requested 24 hours before the due date of the assignment. Please propose a reasonable new due date (usually within a week). If an extension is not granted, papers will lose one letter grade per day late.

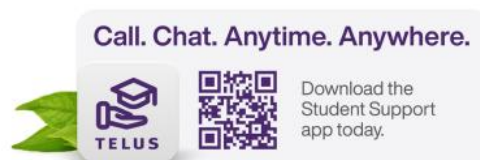

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
