CATALOG COURSE DESCRIPTION:

This course will introduce students to a variety of issues within the context of leadership. Through an assortment of learning methodologies such as written case studies, video case analysis, and interactive learning processes, the student will not only study leadership but also ethics. This course will be presented to an integrated group of students from public safety professions. A focus of this course is to provide public safety members with a greater understanding and appreciation of the concerns and issues involving leadership and ethics, which exist within the realm of public safety leadership. Further, it is the goal of this course for each student to exercise effective leadership in all aspects of life.

PREREQUISITES: None - This class is intended for BAAS-FESA students. Others may attend with approval of their respective school or department.

STUDENT LEARNING OBJECTIVES:

1. Understand the role of the fire officer in the context of leadership, ethics, and values.
2. Understand and identify the fire officer's role and responsibility to exercise leadership in the community.
3. Through a process of personal growth, understand and apply leadership principles in their personal, family, community, and professional lives.

4. Develop confidence in their ability to exercise leadership, as delegators, conflict managers, team-builders, coaches, and strategic thinkers.
5. Develop a broader view of the cultural and political dynamics of organizations
6. Recognize their ability to develop relationships in the context of exercising leadership and have a positive impact on individuals and organizations.
7. Understand the significance of shared vision and communication in effective leadership.
8. Recognize the process, importance, risks, and rewards of ethical, principle-centered decision making.
9. Expand their insight into the importance of maintaining ethics while meeting the challenges of leadership in the public safety field.
10. Understand the importance of integration and collaboration among all stakeholders, public and private, to meet the challenges of leadership in the public safety field.

REQUIRED MATERIALS:

- **TIME:** You are expected to spend 5-10 hours per week for the course.

GRADING POLICY: The final course grade will be based on your performance on the quizzes, exams, assignments and class participation using the following weights:

The final letter grades will be assigned as follows: Above 90% ⇒ A; 80 – 89% ⇒ B; 70 – 79% ⇒ C; 60 – 69% ⇒ D; Below 60% ⇒ F.

VANTAGE COMPLETION: This course requires the use of SAGE Vantage, an online learning environment that includes access to the entire text and integrated assignments, including multimedia activities, concept-based knowledge checks, and end of chapter reading quizzes. **Completion of coursework in Vantage will make up 15% of your overall course grade.** Use the provided links in Blackboard, to access SAGE Vantage.

CHAPTER QUIZZES: There will be a chapter quiz for each chapter in SAGE Vantage. Questions will emphasize understanding and applications of concepts and topics covered in the chapter. There will be fifteen questions for each quiz randomly selected from a bank of questions. Each chapter quiz may be taken a second time, the best grade will be recorded. (Different questions will be randomly selected.) Chapter quizzes must be completed by the due date. **NO CREDIT will be**

given for Chapter Quizzes submitted late. All Chapter quizzes are available in Vantage from the beginning of the semester which will allow students to work ahead if needed.

ASSIGNMENTS: There will be several case study assignments during the semester. The objective of these assignments is to analyze and apply the learned leadership concepts specifically to the fire and emergency services. Details of the assignments will be provided in Blackboard. **Ten points will be deducted from assignments submitted after the deadline.**

RESEARCH PAPER: Due to the online format of this class, the final assignment will be a research-based paper. The purpose of the research paper is to demonstrate mastery of the course learning objectives. Specific requirements and the grading rubric for the research paper will be presented in Blackboard. Ten points will be deducted from research papers submitted after the deadline.

DISCUSSIONS/CLASS PARTICIPATION:

There will be several discussions during the semester. The discussions topics are designed for student-to-student learning. Below are guidelines for the discussions:

1. Do not only respond to the initial questions for the discussion, but rather carry on a dialogue with your classmates as well. This is a discussion, not just a question and answer session. It is one of the items that make a good online course and establishes community. If you only respond to the question, it makes our discussion more of an "exam" rather than a dialogue.
2. Do not get caught up in "winning" the debate. We are here to learn the material, to discuss matters of importance with others, and to enjoy learning.
3. Read all postings from your classmates. We can all learn from each other's perspectives and experiences.
4. When you reply to a post, don't just say "I agree." Give the person or person's name you are agreeing with, a brief, sentence or two, summaries of what they said you are agreeing with, and then your views. You might also consider changing the subject line to reflect your posts. Make it easy for us to figure out who you are talking to and what you are talking about.
5. If you express an opinion, support it with material from our readings. When you quote, summarize, or paraphrase from the text be sure to give the page number(s).
6. Three posts is the bare minimum—one originating with you and two responses to posting from classmates. You should plan on posting on more than one or even two days in order to allow yourself to stay involved with the class.
7. Remember to check back on your thread to see what questions have been asked of you. Answering questions posted for you **is required**.
8. All posts must be completed during the week of the discussion. Late posts do not count and thus a poor grade may be recorded. Discussion grades will be posted after the discussion week has ended.
9. If you do not participate in our class discussions you will be institutionally dropped from the course. If you are unable to participate in the online discussions, then you should withdraw from the course.

CLASS ATTENDANCE AND PARTICIPATION: The class is delivered entirely online. Students are required to participate in weekly discussions. These discussions enhance learning and provide

opportunity for fellow students to interact and participate with other students. Students are responsible for the materials covered in class. Class participation is highly encouraged as it makes class more interesting and enhances the learning experience. Students are strongly encouraged to ask questions and participate in class discussions and problem solving. Good attendance and participation will be rewarded when final grades are assigned.

ARTIFICIAL INTELLIGENCE (AI) POLICY: AI can be used for initial research, idea generation, etc. No Use of generative AI is permitted for final assignment submissions. All work submitted by students will be generated by the students themselves, working individually. Students should not have another person/entity do the writing of any portion of an assignment for them, which includes hiring a person or a company to write assignments and/or using artificial intelligence (AI) tools like ChatGPT. Submission of any AI-generated content in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Drop Policy

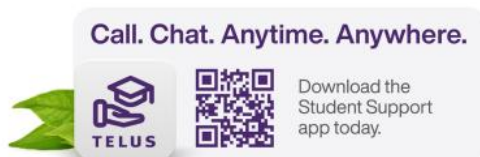

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class).
