Course Description:

This course is designed to introduce students to critical issues of criminal justice.

Course Learning Outcomes:

The primary objective of this course is to introduce you to some of the prominent issues in criminal justice. Many of the elements of this course will help you improve your critical thinking and problem-solving skills, which may be carried over into non-research-related aspects of life. Upon successful completion of this course, you will have an increased understanding of historical and current issues in criminal justice. The six main topics that will be covered in this course are: 1) *Racism in Policing*, 2) *Diversity in Policing*, 3) *Mass Incarceration*, 4) *Privatization of Prison*, 5) *Class and the Courts*, and 6) *Wrongful Convictions*.

Required Textbook:

No textbook is required for this class. All reading materials (research articles) will be provided via Black Board.

Class Format:

This course will consist of research articles, discussion forums, policy papers, and a final report. You are expected to complete all the assigned readings, discussion forums, policy papers, and the final report.

Assessments

Discussion Forum (150 pts)

You will complete six discussion forums worth 25 points (please see rubric in the instructions document provided on BB) each throughout the semester. Your main goal here is to argue your opinion regarding each topic you are required to read each week. Detailed instructions about the discussion forum are provided on BB. Minimum word count for this assignment is 800 for your original discussion post, and 400 words each for your peer response (minimum of two). Additionally, APA format (including structure and citation methods) is required. If you do not meet the minimum requirement, it will be an automatic zero.

Policy Implication Paper (150 points):

You will complete six policy implication paper throughout the semester. Please see the instructions provided on Black Board for detailed information. Your main goal is to come up with a policy for the issues that you have identified in your discussion post. The minimum word count is 1200 and APA format required (or else automatic zero).

Research Report (100 points):

For your final report, you will write a final report on the issues that you believe is problematic in American criminal justice system. NOTE, YOUR TOPIC (issues) MUST BE SOMETHING THAT WE HAVE NOT COVERED IN CLASS. Afterwards, the back end of your final report will be your policy implications. Instructions, due date, rubric, and example is provided on Black Board.

Financial Aid and Verification of Attendance

According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC)

The Jaguar Writing Center provides writing support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, plan, draft, and revise their written assignments. The Six-Drop Rule

Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students

Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide reasonable accommodation for pregnant students as it would be provided to a student with a temporary medical condition that is related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Students' Rights and Responsibilities

The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built. This philosophy acknowledges the existence of both rights and responsibilities, which is inherent to an individual not only as a student at Texas A&M University-San Antonio but also as a citizen of this country.

Students' Rights
