COURSE DESCRIPTION:

Spanish background, Anglo-American settlement, the Revolution and Republic and statehood; economic, cultural and political development. TSI Restriction(s): Reading, Math, and Writing

Prerequisites: HIST 1301, HIST 1302.

ASSIGNMENTS:

ATTENDANCE (10%): Students are expected to attend classes in person each week. See Course Calendar, pages 2-4, for class meeting dates. If you know in advance that you will miss a scheduled class meeting, please notify your instructor immediately so that you will not be marked absent. **You will be allowed one unexcused absence**, but you are still responsible for any missed assignment. Note that two unexcused absences from class meetings will result in a drop of one letter grade from your overall final grade for the course and an “F” for three or more unexcused absences. Communication with your instructor is key.

READINGS, DISCUSSION, QUIZZES (30%): Students will be graded on the quality of their contributions and ability to analyze, think critically, and discuss course concepts. Students will submit assignments via Blackboard Ultra (BU) or a hard copy during class and take quizzes in-person based off the assigned readings, discussion, film, primary and secondary source analysis. Points will be subtracted from your score on any assignment that is turned in past the due date.

BOOK REVIEW (20%): I will provide you with a Guide (& Rubric) to Writing the Book Review via Blackboard Ultra. The format will be three pages maximum in length (or around 750 words), typed, double-spaced, 12-point font, and preferably Times New Roman. For this assignment, you will read the required book by Andres Tijerina, *Tejano Empire: Life on the South Texas Ranchos*. The **Due Date** for your book review is by **Sunday, November 8**, submitted through Turnitin in BU, which checks plagiarism and AI. See Academic Misconduct Policy on page 10. Points will be subtracted from your score for being turned in past the due date.

EXAMS (40%): I will provide you with a Guide to the Mid-Term Exam and the Final Exam via Blackboard Ultra about one week prior to each exam date. The format for both exams will be a short-answer section and a long-essay section. Note: Bring a blank Bluebook or Greenbook with you to write your responses. 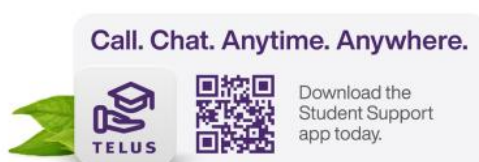

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC): The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as eportfolios, class presentations, or other digital multimedia projects. The WLDCC offers face-to-face, synchronous online, and asynchronous digital appointments. Students can schedule appointments with the WLDCC in JagWire under the Student Services tab. Click on “Writing, Language, and Digital Composing Center” to make your appointment. Students wanting to work in realtime with a tutor can schedule an “Online Appointment.” Students wishing to receive asynchronous, written feedback from a tutor can schedule an “eTutoring” appointment. The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does

not affect the student's GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as "F" grades and will impact the student's GPA.

Pregnant/Parenting Students: Texas A&M-San Antonio does not require a pregnant or parenting student, solely because of that status or issues related to that status, to (1) take a leave of absence or withdraw from their degree or certificate program; (2) limit the student's studies; (3) participate in an alternative program; (4) change the student's major, degree, or certificate program; or (5) refrain from joining or cease participating in any course, activity, or program at the University. The university will provide such reasonable accommodations to pregnant students as would be provided to a student with a temporary medical condition that are related to the health and safety of the student and the student's unborn child. These could include maintaining a safe distance from substances, areas, and activities known to be hazardous to pregnant individuals and their unborn child; excused absences because of illness or medical appointments; modified due dates for assignments; rescheduled tests/exams; taking a leave of absence; and being provided access to instructional materials and video recordings of lectures for excused absences, if these would be provided to any other student with an excused absence. Students' Rights and Responsibilities: The following statement of students' rights and responsibilities is intended to reflect the philosophical base upon which University Student Rules are built.
