Course Description and Prerequisites

This course offers hands-on experience in ichthyology, the study of fishes. Students will learn the principles of fish taxonomy, morphology, and ecology through laboratory exercises and specimen identification. The course emphasizes key techniques for classifying and understanding the diversity of fishes with a focus on local species. Prerequisites: C or better in BIOL 1307 or BIOL 1309.

Corequisites: BIOL 4331.

Learning Outcomes

This course is to familiarize the student with the basic principles of ichthyology, and the interrelationship between fishes and their environment, including interactions with other organisms that leads to a diversity in form and function on Earth. This course is to give the student hands-on experience with specimens to illustrate the anatomy and diversity of fishes.

Students will:

- Use and understand the primary scientific literature of science,
- Gain a familiarity with core concepts of biology from genetics, evolution, and a diversity of biotic systems over the course of the semester
- Gain experience in using current technologies associated with the biological sciences.
- Recognize all major taxonomic groups of fishes.
- Identify select freshwater fishes of Texas and marine fishes in the Gulf of Mexico.

- Identify select fishes of specific families.
- Identify basic anatomy of fishes.

Description of Graded Work

Type	Description
Lab Practicals 40%	Three lab practicals will be given during class time. Practicals will cover material from lab only.
Lab Notebook 30%	During the semester, you will keep a lab notebook. Your notebook is your record of what you observe, learn, measure, draw, and conclude during laboratory activities. You are responsible for keeping your notebook organized and up to date. There will be random, unannounced checks throughout the semester that will be graded. You will also be able to use your lab notebooks during your lab quizzes. Lab notebooks must be on paper, must be completed by you, and must be hand-written/ hand drawn.
Lab Quizzes 20%	Each week (except on practical days), there will be a lab quiz covering the previous week's lab. The lab quizzes will be in class and on paper. These will be given at the beginning of lab. If you come to lab late, you will have less time to complete the lab quiz. One lab quiz will be dropped.
Field Techniques/ Trips 10%	After each practical, we will use the time to discuss and practice field techniques, in hopes to show these techniques off during a field trip to Cassin Lake.

Make-up and Late Work Policy

Practicals

You may make up a practical only if:

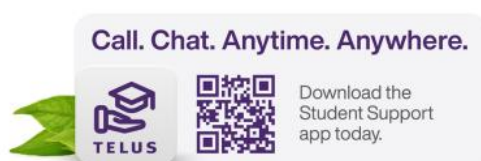

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance.
