Introduction to Philosophy

Course Description: This course provides an introduction to the examination of major philosophical issues such as the existence of God, freedom and determinism, the relation between the mind and the body, moral rights and obligations, and the nature and limits of human knowledge. The focus will be these important issues and what classical and contemporary philosophers have said about them. This course meets the standards for the “Language, Philosophy, and Culture” category of courses under the core curriculum. TSI Restriction(s): Reading and Writing

Learning Outcomes

Upon successful completion of this course, students will be able to:

- Identify major philosophers and themes in the history of philosophy.
- Communicate philosophical ideas and arguments effectively through speaking and writing.
- Apply critical thinking skills to develop and evaluate philosophical questions and arguments.
- Demonstrate close reading and understanding of philosophical texts.
- Examine assumptions in their thinking and practice philosophical self-reflection.
- Engage with different philosophical approaches to ethical issues facing individuals and groups.

Required Texts: The texts for this course will be various papers, excerpts from books and articles related to the topics under discussion, all of which will be uploaded to Blackboard.

Course Requirements: There will be 10 quizzes (25%), two midterm exams (50%), and a final exam (25%). Due dates for the midterms and final exam are scheduled below. Quizzes will open at 12 A.M. each Friday. Midterm I, Midterm II and the Final Exam will open right after class on Wednesday and will be open until 11:59 P.M. on Friday.

Classroom Procedures

Late Assignments/Extra Credit: Late assignments will not be accepted without a doctor’s note, or some requisite indication of an emergency. If some conflict with work or family occurs, **at least a 2-day advanced notice is required, along with some form of written indication of the conflict. Any attempt to turn in an assignment outside of these criteria will not be accepted and any communication on the matter will be ignored.**

There are no plans for extra credit assignments, though there will be extra credit questions on exams.

Participation: Participation and discussion are highly encouraged so it is imperative that you familiarize yourself with the material and keep up with works assigned for reading. The expectation is that students will gain an understanding of the various topics covered.

Classroom Etiquette: Distractions, such as phones, alarms, and other electronic devices will generally not be tolerated. Any exceptions will need to be cleared with me before class. Written notes would be preferred to notes taken on laptops, but laptops are allowed. Cheating will not be tolerated. Use of AI tools (such as Chat GPT, for example) to complete assignments will be considered a form of cheating.

The topics we discuss may involve talking about issues which are sensitive. These topics should be discussed with respect, courtesy, and understanding for different perspectives. Insults, dismissiveness, and similar attitudes will not be tolerated

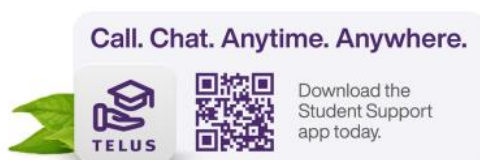

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Any student receiving federal financial aid who does not attend by the census date will have their financial aid terminated and returned to the

DoE. Please note that any student who stops attending at any time during the semester, a Care report will be submitted, and you will possibly be dropped from the class. Your financial aid may have to be recalculated and a portion of your federal aid may have to be returned to the DoE.

The Six-Drop Rule: Students are subject to the requirements of Senate Bill (SB) 1231 passed by the Texas Legislature in 2007. SB 1231 limits students to a maximum of six (6) non-punitive course drops (i.e., courses a student chooses to drop) during their undergraduate careers. A non-punitive drop does not affect the student’s GPA. However, course drops that exceed the maximum allowed by SB 1231 will be treated as “F” grades and will impact the student’s GPA.

Students' Responsibilities

Option 1 - No Use of Generative AI Permitted

Option 2 – Use of Generative AI Permitted Under Some Circumstances or With Explicit Permission

There are situations and contexts within this course where you may be asked to use artificial intelligence (AI) tools to explore how they can be used. Outside of those circumstances, you should not use AI tools to generate content (text, video, audio, images) that will end up in any student work (assignments, activities, discussion responses, etc.) that is part of your evaluation in this course. Any student work submitted using AI tools should clearly indicate with attribution what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, students should reach out to their instructor for clarification before submitting work for grading. Use of AI-generated content without the instructor's permission and/or proper attribution in this course qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 3 – Broader Use of Generative AI Permitted Within Guidelines

Use of artificial intelligence (AI) tools, including ChatGPT, is permitted in this course for students who wish to use them. To adhere to our scholarly values, students must cite any AI-generated material that informed their work (this includes in-text citations and/or use of quotations, and in your reference list). Using an AI tool to generate content without proper attribution qualifies as academic dishonesty and violates Texas A&M-San Antonio's standards of academic integrity.

Option 4 – Customized Policy Generative AI Policy
