Course Overview: Students will study topics from college algebra (linear equations, quadratic equations, functions and graphs, inequalities), mathematics of finance (simple and compound interest, annuities), linear programming, matrices, systems of linear equations, and applications to management, business and social sciences. This course meets the standards for the Mathematics category of courses under the core curriculum. **Prerequisites:** Evidence of math equivalent to High School Algebra II ("C" or higher) or placement; Requires passing TSIA Math score.

Course Materials

REQUIRED: Online access code for *Mathematics with Applications in the Management, Natural & Social Sciences* by Lial, Hungerford, Holcomb (13th edition) with MyMathLab, Pearson Publishing (E-book included with access code). ****Access codes are available in Blackboard.**

OPTIONAL: Students can purchase a loose-leaf version of text for a low cost if desired (check bookstore).

Calculators: A scientific non-graphing calculator is permitted; TI-30XS is recommended. No cell phone or graphing calculators will be allowed on exams, and online math utilities (e.g., Desmos) are also not allowed.

Student Learner Objectives

MATH 1324 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key algebraic concepts to include recognizing, identifying, solving, analyzing, and explaining applications of various mathematical functions in management, economics, and business problems. Upon completion of this course, students will:

1. Apply elementary functions, including linear, quadratic, polynomial, rational, exponential, and logarithmic functions to solve and interpret real-world problems.
2. Recognize and solve mathematics of finance problems, including the computation of interest, annuities, and amortization of loans.
3. Apply basic matrix operations, including linear programming methods, to solve business application problems.
4. Demonstrate fundamental probability techniques and application of those techniques, including expected value, to solve problems.
5. Interpret and apply matrix techniques and probability analyses to model applications to management, economics, and business problems.

Course Requirements and Expectations

Class Attendance: Students are expected to attend class lectures regularly. Missing more than 8 hours of class time without proper documentation can result in a failing grade for the course. Be aware of what has been covered in every class and any announcements and course policy changes made in class.

Announcements and changes will also be communicated through Blackboard. You are welcome to ask questions during my office hours; however, it is your responsibility to learn the material.

Learning New Content: In this face-to-face class, your instructor will hold 2 lectures each week during our scheduled class time. If you miss a class meeting, be sure to reach out to a classmate for the class notes. For additional information or details, you can also watch the **section video presentations** in the MyLab Math program. These videos can be accessed from the Course Links in Blackboard or in the Chapter Contents menu. If you don't attend class regularly, you will have a difficult time with the HW and quizzes each week.

Homework: Most homework and quizzes will be completed online in MyLab Math (MLM), along with occasional assignments or activities posted in Blackboard. You will need an access code that can be retrieved

on BlackBoard through Access Pearson. All due dates are listed in MLM. You can complete the assignments until 11:59 pm of the due date listed. The homework may be attempted multiple times in order to increase your homework grade. No late assignments will be accepted nor make-ups allowed. If you are consistently struggling with the deadlines, please reach out to me so that we can discuss possible solutions.

Quizzes: Weekly quizzes will be due in MyLab Math or occasionally completed in recitation (Tuesday help session). Online quizzes may be attempted three times, and each quiz attempt has a time limit. Only the highest score will be counted. No late assignments will be accepted nor make-ups allowed. At the end of the semester, the lowest quiz grade will be dropped.

Tests: Three unit tests are scheduled during the semester and a comprehensive final exam. All exams are to be completed on the scheduled date in-person on recitation days to allow for extended testing time. You should show all your work in order to get full credit for the problems. Students will be allowed to use a scientific calculator on the tests. In case you miss an exam or find out that you will miss an exam, you should contact me either in person or by e-mail, at least one week in advance of the exam for non-emergency cases or within 24-hrs of the scheduled exam date for emergency cases. Any missed exam counts as a 0 unless the student has a valid documented excuse and contacts me as soon as possible after the excuse for missing the test arises. Examples of valid documented excuses are sickness documented with a doctor's note, death in the family documented with a copy of the death notice, attending university-sponsored events with a Dean's excuse, etc. Minor headaches or attending sports events (without Dean's excuse) are not examples of emergency situations. Other than described above, no make-up exams will be given, but the final exam can replace your lowest test grade. Test dates are listed below. Final Exam: In order to pass this class students must take a comprehensive final exam scheduled during Finals Week. Final exams cannot be rescheduled or missed (for dire and unforeseen medical or family emergencies, students must consult with me). The final exam may be used to replace your lowest regular exam grade. **The final exam must be completed on the scheduled date. No exceptions.**

Gradebook: The gradebooks in MyLab Math and in Blackboard keep a running average of your grade. I will review all quizzes in order to assign partial credit where possible. I will NOT review HW answers because you have unlimited attempts for each problem.

CLASS RULES

1. **Regular participation and attendance is VERY IMPORTANT in this class!** This is a FOUR hour course (3 hour lecture + 1 hour recitation), so expect to work on your Math work very regularly. Waiting to work on one day at the end of the week would be disastrous for this course!! Assignments will be due throughout the week on Tuesdays and Sundays – watch deadlines in MyLab Math closely.
2. Please do not ask me to extend the due dates. Work ahead on the assignments instead (remember... if something can go wrong, it will).
4. If you need additional help, please ask! 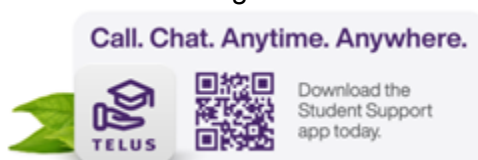

Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance.
