Catalog Description:

In-depth combined study of algebra, trigonometry, and other topics for calculus readiness. This course meets the standards for the Mathematics category of courses under the core curriculum and address the following required objectives: Critical Thinking, Communication, and Empirical Quantitative Skills.

Prerequisites: MATH 1314 College Algebra with a grade of "C" or higher.

Credits: 3

Student Learning Outcomes

- *Demonstrate and apply knowledge of properties of functions.*
- *Recognize and apply algebraic and transcendental functions and solve related equations.*
- *Apply graphing techniques to algebraic and transcendental functions.*
- *Compute the values of trigonometric functions for key angles in all quadrants of the unit circle measured in both degrees and radians.*
- *Prove trigonometric identities.*
- *Solve right and oblique triangles.*

MATH 2312 helps students develop critical thinking, communication, and empirical and quantitative skills by focusing on student understanding of key algebraic concepts and appropriate applications related to everyday experience.

Grading

A recitation has two possible final grades: CR (credit) or NC (no credit). To receive the CR grade for the recitation, a student must attend and participate fully at least 75% of the recitation meetings (at least 11 out of 14 total recitation meetings). That probably will not be sufficient attendance to pass the lecture portion of the course, MATH 2312, since there will be 11 Weekly Quizzes administered during recitation meetings and those quizzes will be applied to your grade for MATH 2312.

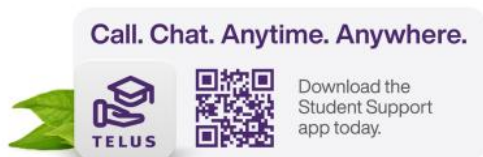

Counseling/Mental Health Resources: As a college student, there may be times when personal stressors interfere with your academic performance and negatively impact your daily functioning. Financial Aid and Verification of Attendance: According to the following federal regulation, 34 CFR 668.21: U.S. Department of Education (DoE) Title IV regulation, a student can only receive Title IV funds based on Title IV eligibility criteria which include class attendance. If Title IV funds are disbursed to ineligible students (including students who fail to begin attendance), the institution must return these funds to the U.S. DoE within 30 days of becoming aware that the student will not or has not begun attendance. Faculty will provide the Office of Financial Aid with an electronic notification if a student has not attended by the published Census Date (the first week of class). Any student receiving federal financial aid who does not attend prior to the published Census Date (the first week of class) will have their aid terminated and returned to the DoE. Please note that any student who stops attending at any time during the semester may also need to return a portion of their federal aid.

Jaguar Writing, Language, and Digital Composing Center (WLDCC): The WLDCC provides support to graduate and undergraduate students in all three colleges as well as faculty and staff. Writing tutors work with students to develop reading skills, prepare oral presentations, and plan, draft, and revise their written assignments. Our language tutors support students enrolled in Spanish courses and students composing in Spanish for any assignment. Our digital studio tutors support students working on digital projects such as eportfolios, class presentations, or other digital multimedia projects.
